As a result, there has been \$5,000 unfavorable prior year development during the nine months ended September 30, 2011 as compared to a \$54,000 favorable development during the nine months ended September 30, 2010. The change is generally the result of ongoing analysis of recent loss development trends. Original estimates are increased or decreased as additional information becomes known regarding individual claims.
