- The Company has no prescribed or permitted accounting practices by the State of Ohio that differ from those found in NAIC SAP.

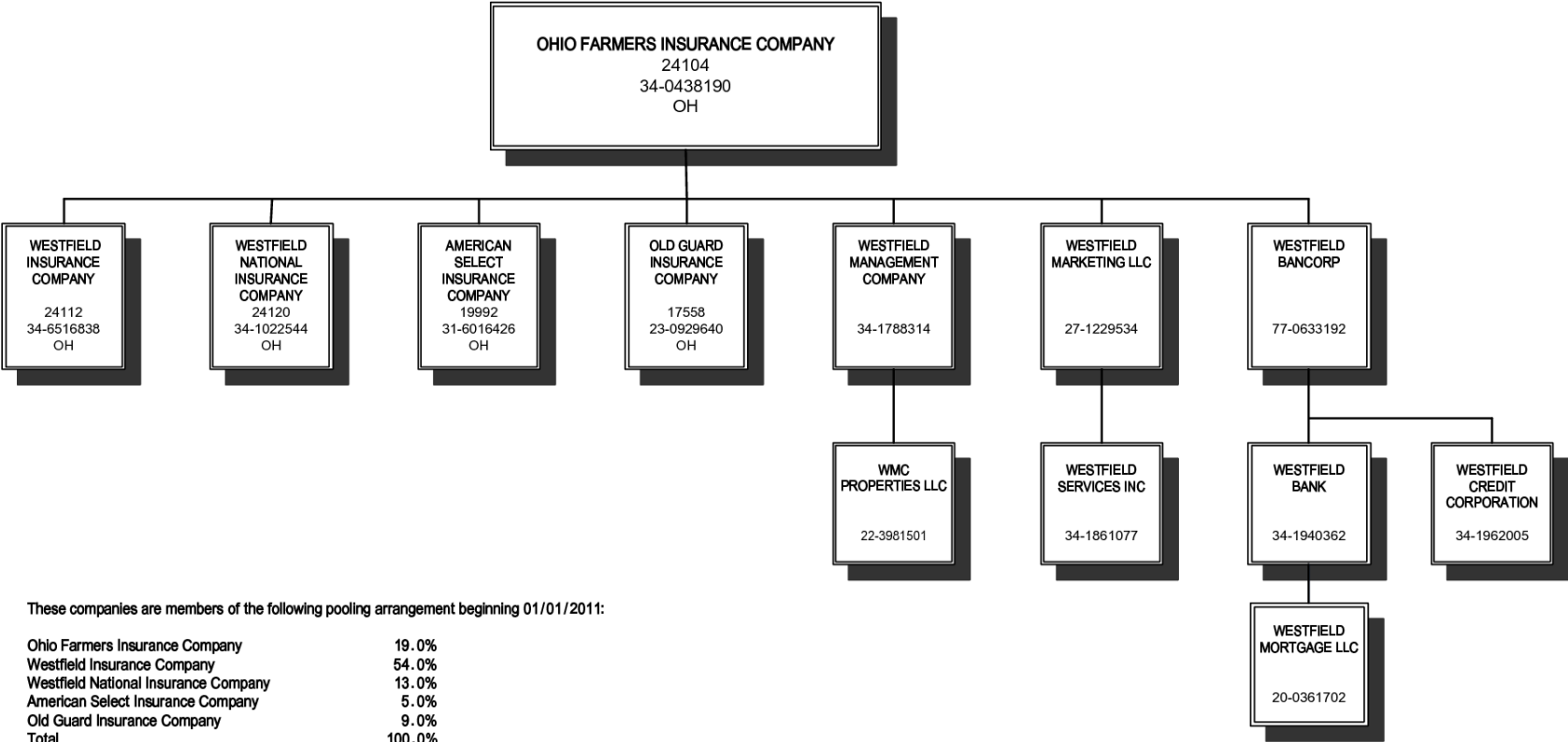
