NOTES TO FINANCIAL STATEMENTS

Note 1 - Summary of Significant Accounting Policies**A. Basis of Presentation**

Consumers Life Insurance Company (the Company) is a stock life insurance company, wholly-owned by Medical Mutual of Ohio (MMO and Parent), a mutual casualty insurance organization. The Company is licensed to sell life and accident and health insurance in 34 states and the District of Columbia.

The accompanying financial statements of the Company have been prepared in conformity with the National Association of Insurance Commissioners' (NAIC) Accounting Practices and Procedures Manual, as prescribed by the Ohio Department of Insurance (ODI). No permitted practices have been utilized in the preparation of these statements.

Note 10 - Information Concerning Parent, Subsidiaries, Affiliates and Other Related Parties

The Company cedes 80% of its total health business to its parent, MMO, pursuant to a quota share reinsurance treaty. In accordance with the agreement, the Company receives up to a 22.1% ceding commission allowance from MMO. Under this agreement, the Company ceded \$12,954,000 in premiums and \$12,215,000 in claims during the first three months of 2012.

During the first three months of 2012, commission expense includes \$1,049,000 of net commissions paid to and retained by wholesale insurance agencies that are affiliates of the Company. For the comparable period in 2011, commissions amounted to \$1,624,000, and for the year ended 12/31/11, these commissions amounted to \$5,413,000.

Effective June 30, 2011, the Company terminated all accident and health contracts written in the states of Indiana and Michigan. New policies with an effective date of July 1, 2011, were issued to these policyholders by the Company's parent, Medical Mutual of Ohio. The Company's life and disability policies issued in those states were unaffected, and the Company continues to underwrite life and disability products in those states.


