Transfers and Servicing of Financial Assets

The Company transferred \$37,500,000 of premiums receivable to Progressive Investment Company, Inc. (“PICI”), a non-insurance affiliate, for \$37,493,885 in cash and/or securities in March, 2013. The related premiums receivable remain in the Company’s assets, and a corresponding liability was established. As the related cash is collected, it is transferred to PICI, and the liability is reduced. These premiums receivable transactions were approved by the Ohio Department of Insurance.

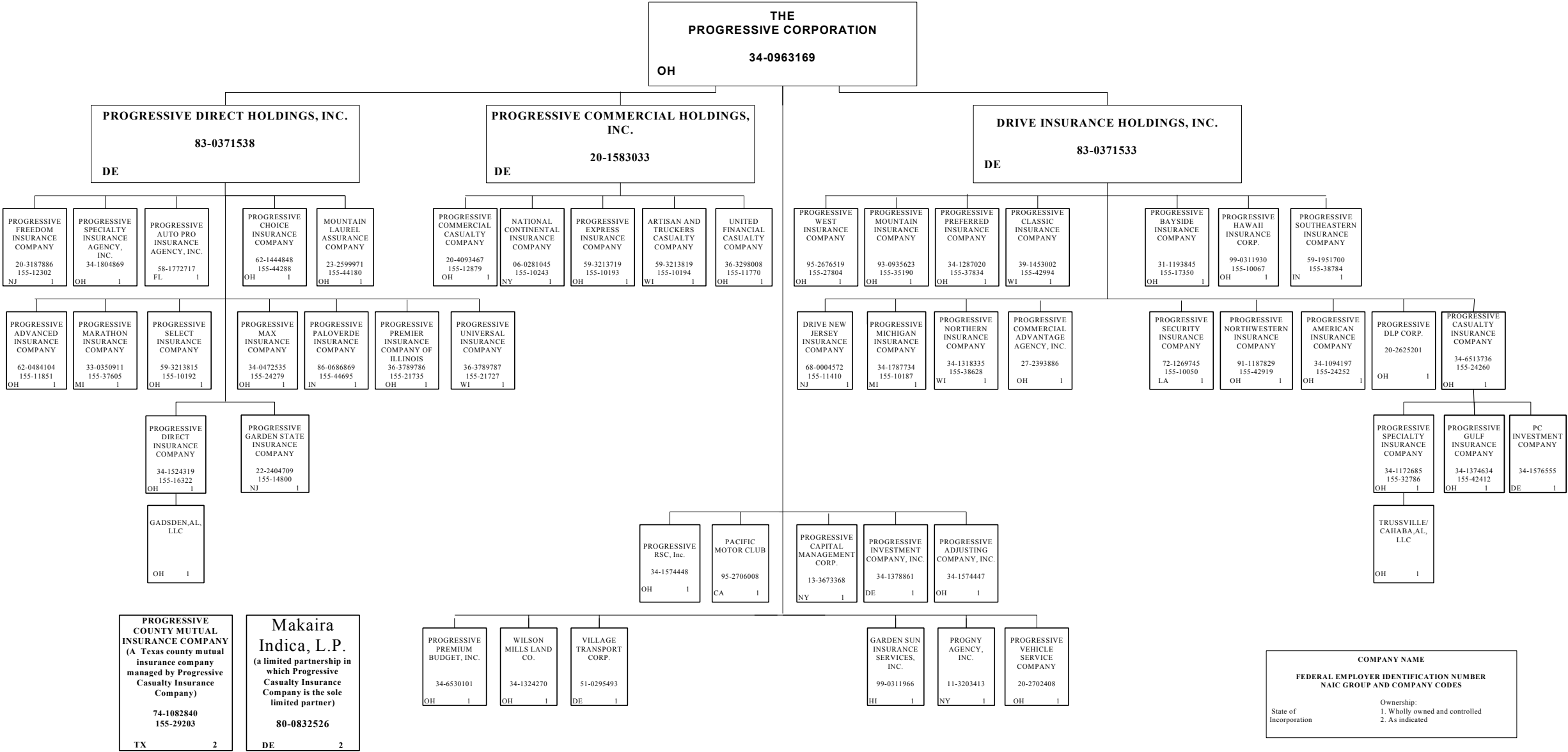
