In response, the Company agreed with a request by the Ohio Department of Insurance to increase the amount of capital in the Company by \$20 million which approximates the net loss recorded in 2012. On May 8, 2013, the Exchange, the Company’s parent, contributed \$20 million to the Company. The contribution will not remove the HFC but will replenish the depleted surplus.

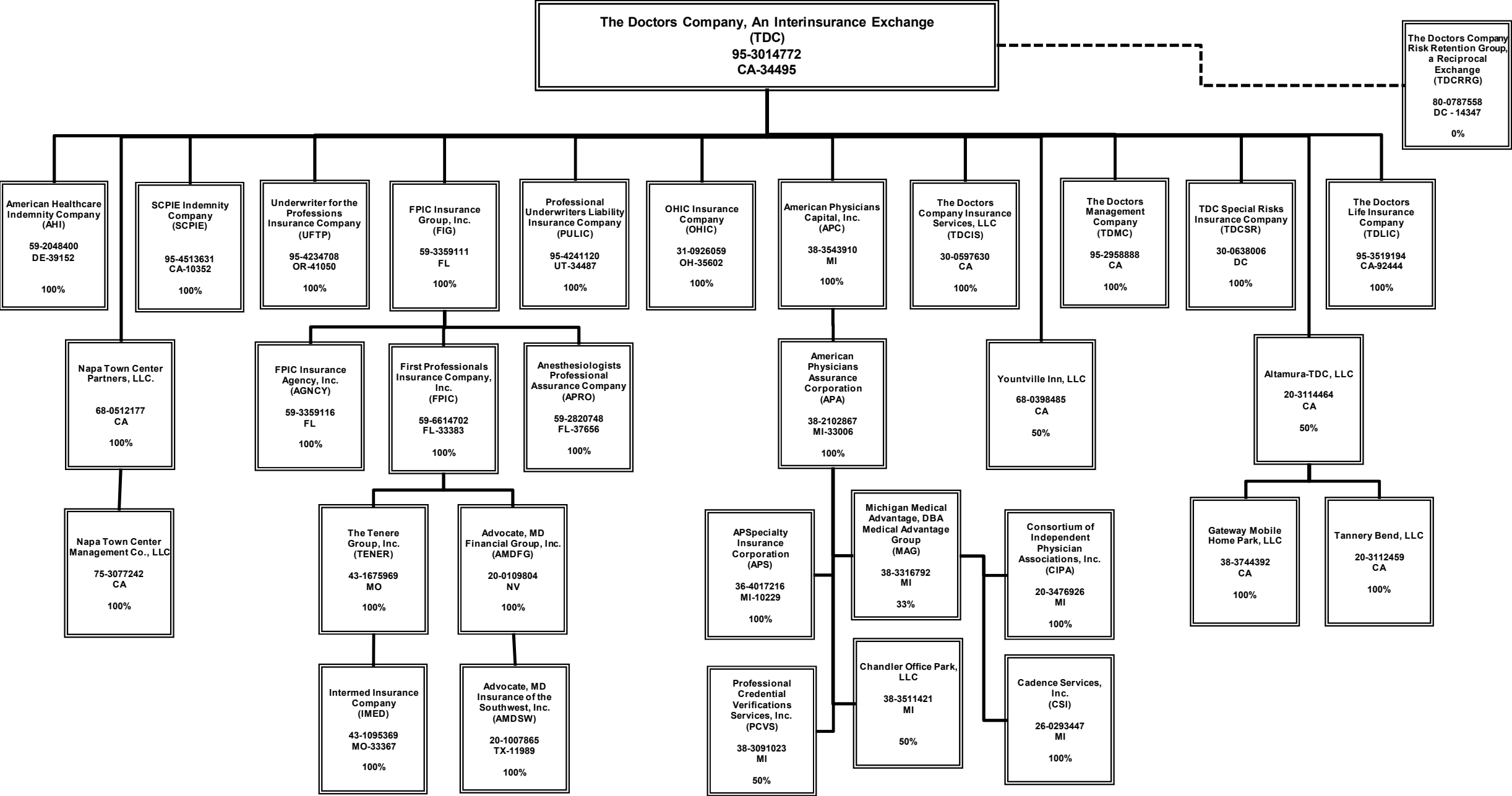
