B. Transfers and Servicing of Financial Assets

The Company transferred \$36,300,000 of premiums receivable to Progressive Investment Company, Inc. ("PICl"), a non-insurance affiliate, for \$36,295,289 in cash and/or securities in September, 2013. The related premiums receivable remain in the Company's assets, and a corresponding liability was established. As the related cash is collected, it is transferred to PICl, and the liability is reduced. These premiums receivable transactions were approved by the Ohio Department of Insurance.

Level 3 - Inputs that are unobservable. Unobservable inputs reflect the Company's subjective evaluation about the assumptions market participants would use in pricing the financial instrument.

The Company's management evaluated whether the market was distressed or inactive in determining the fair value of the Company's securities and reviewed certain market level inputs to evaluate whether sufficient activity, volume, and new issuances existed to create an active market. Based on this evaluation, management concluded that there was sufficient activity in determining the fair market value of the Company's securities.

As of September 30, 2013, the Company did not measure and report any securities at fair value on the balance sheet. All bonds were carried at amortized cost.

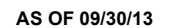
