The primary effect is for those claims previously reported as closed with payment where the Company has recovered 100% of the salvage or subrogation, will now be reported as closed without payment. In addition, claims closed without payment that were reopened and subsequently paid will now be shown as claims closed with payment. Historical claim counts for closed with payment, closed without payment, and the number of claims reported were restated for all Schedule P lines of business primarily due to the reasons cited above. All claims outstanding counts were not restated as they were accurate.
