## D. Loan-Backed Securities

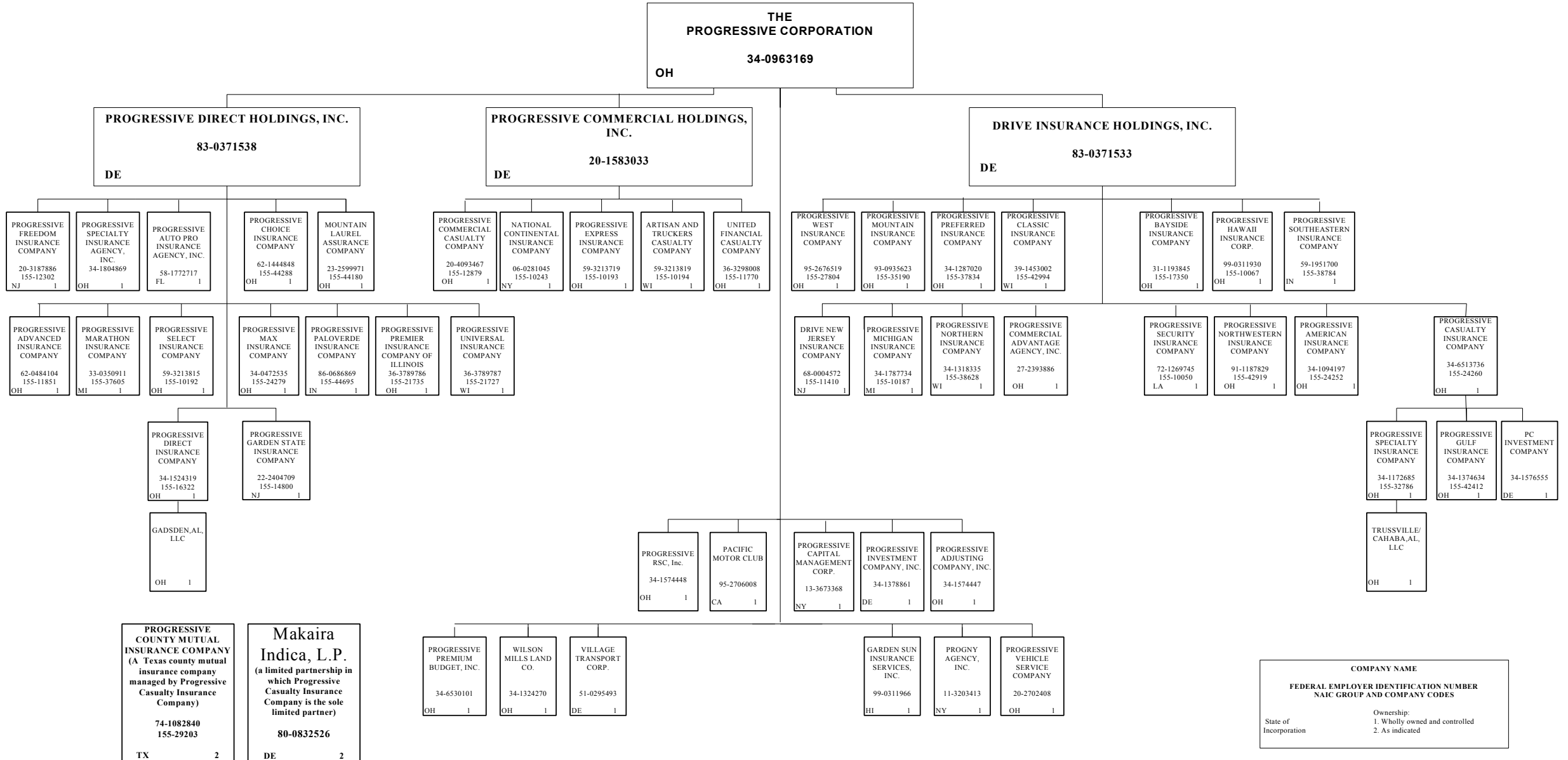
