Unless specifically noted, the Company does not consider a loss from this case to be probable and is unable to estimate a range of loss, if any, at this time.</p> <p>As of June 30, 2014, there was a putative class action lawsuit alleging that the Company charged insureds for illusory underinsured and uninsured motorist coverage on multiple vehicle policies.</p>

	<p>The Company transferred \$55,200,000 of premiums receivable to Progressive Investment Company, Inc. ("PICI"), a non-insurance affiliate, for \$55,194,325 in cash and/or securities in June, 2014. The related premiums receivable remain in the Company's assets, and a corresponding liability was established. 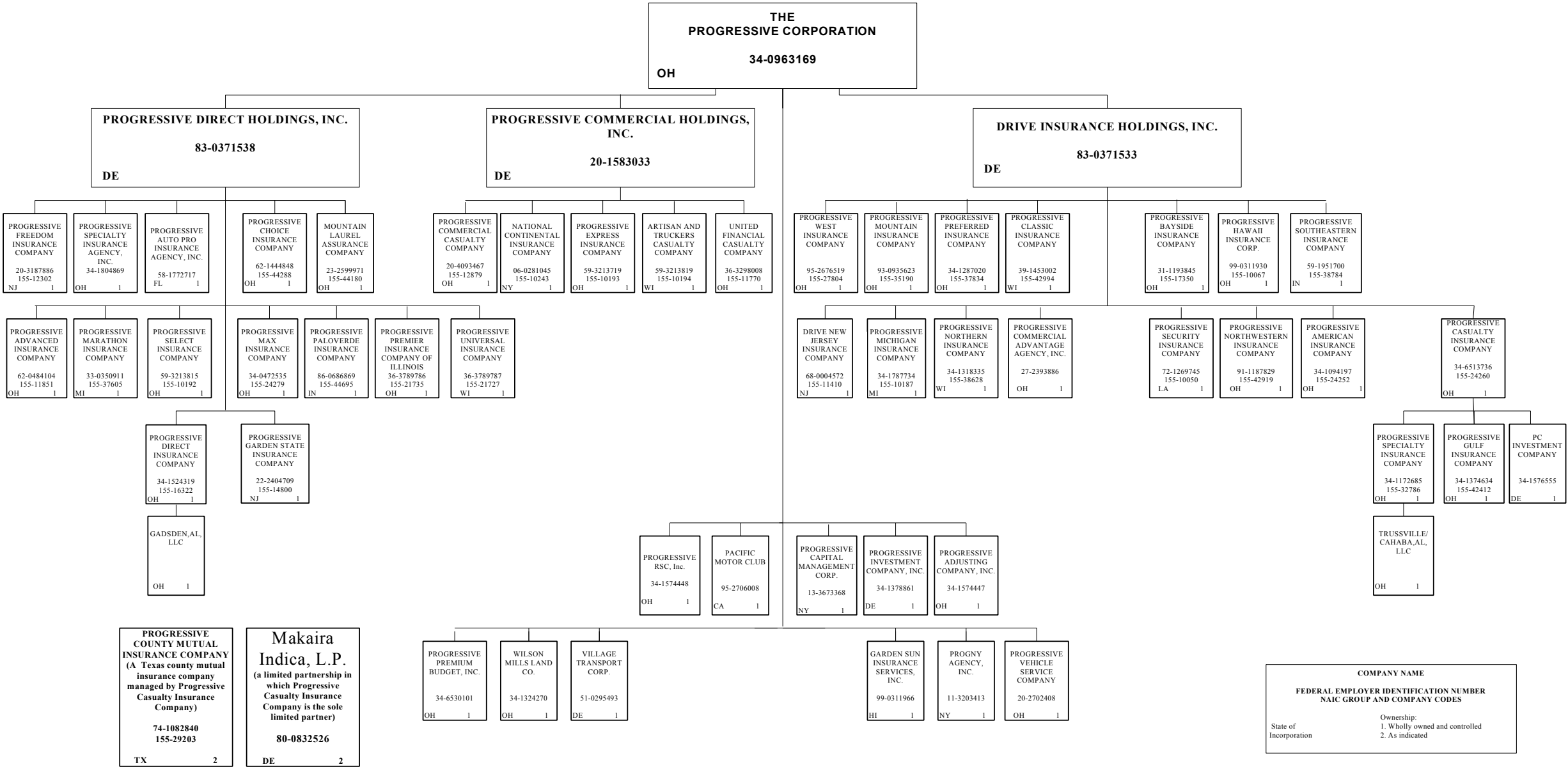

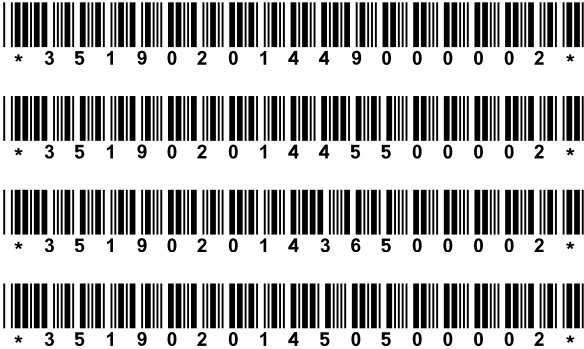
