Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

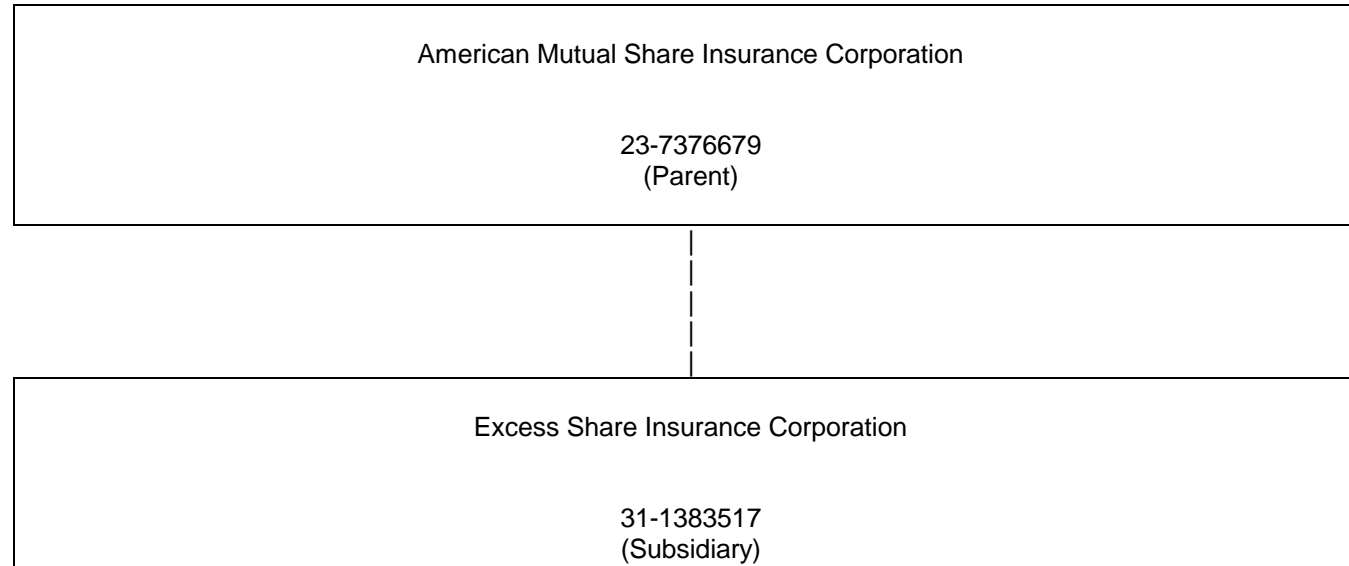
