The Company also has potential exposure relating to lawsuits due to its participation in the management agreement for which it is allocated litigation expenses. 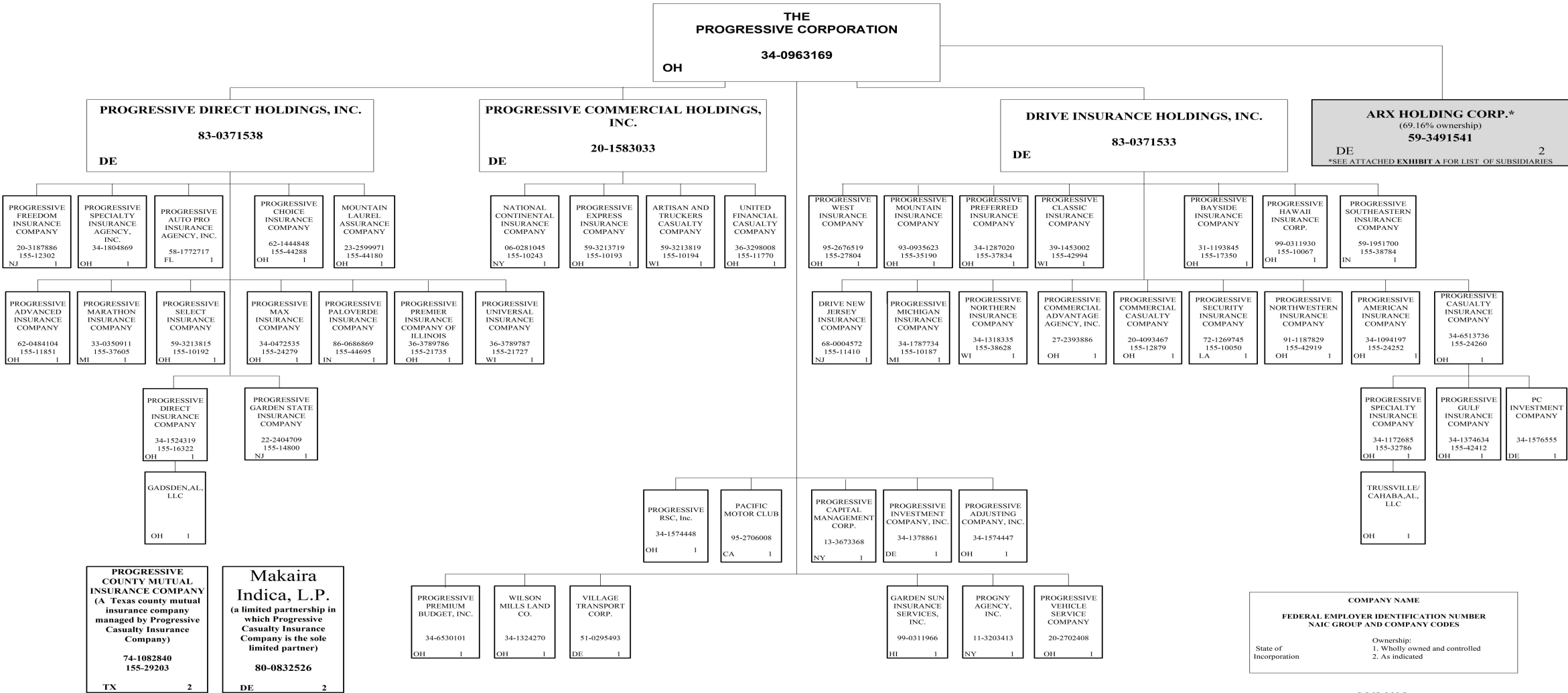

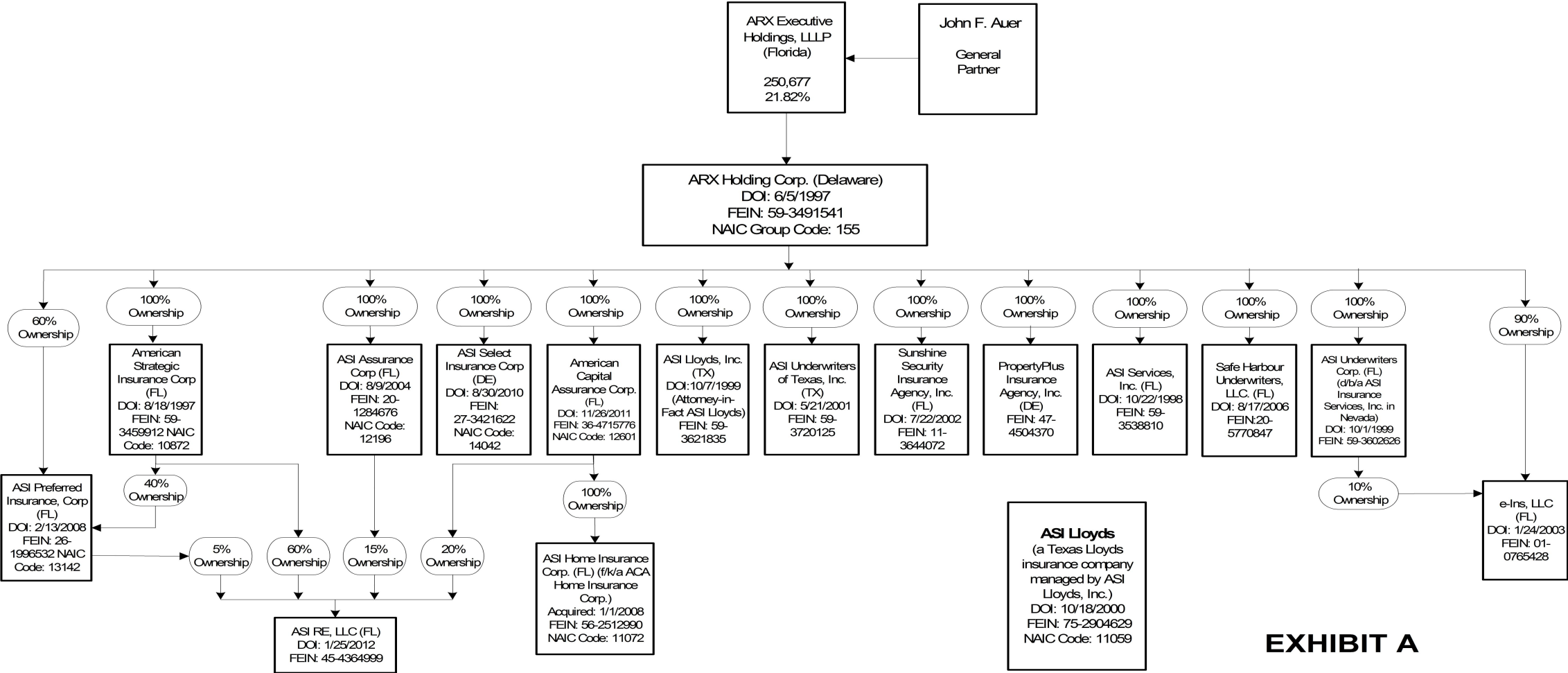
