Therefore, there has been a \$1.8 million favorable prior year development from December 31, 2015 to June 30, 2016. 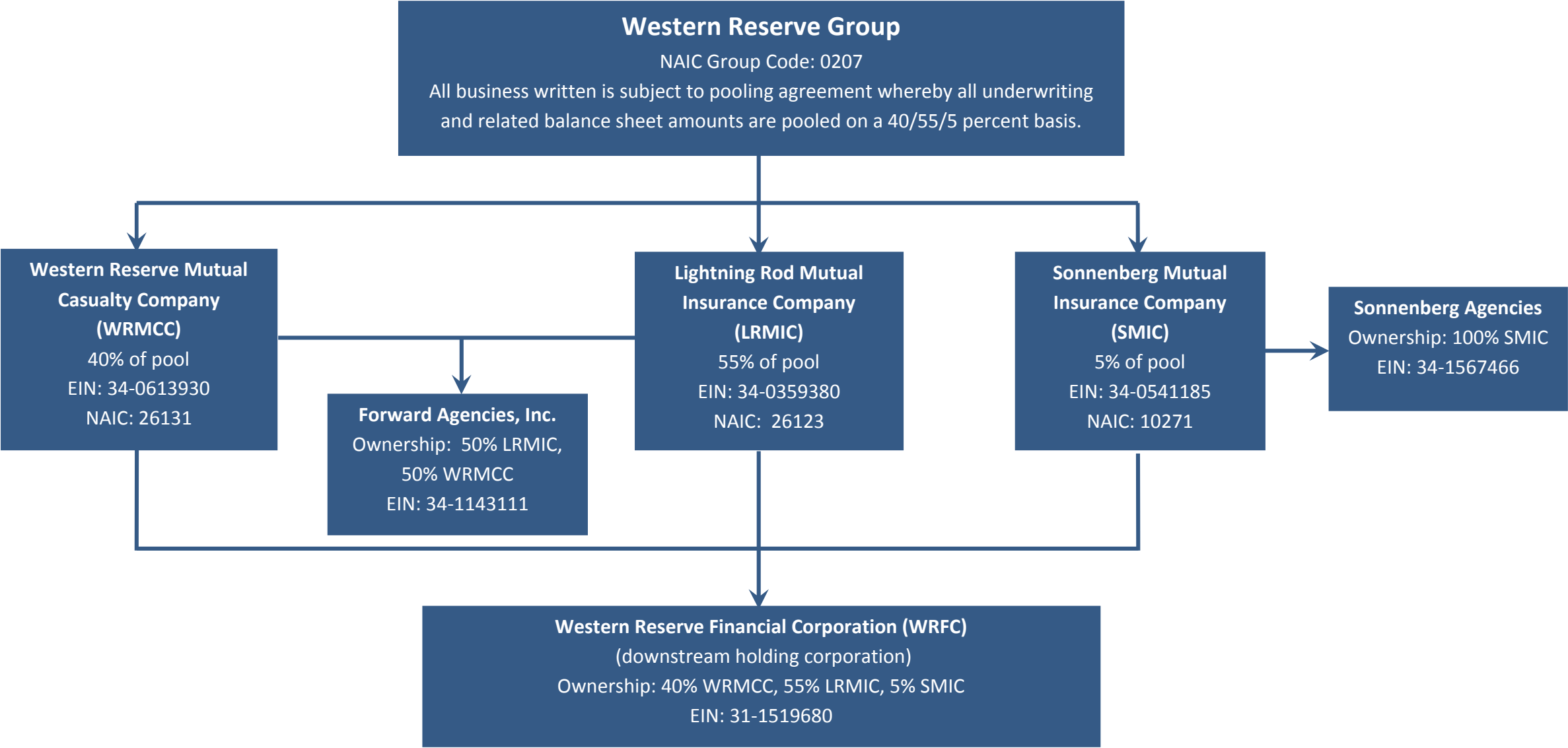
