The statutory basis financial statements of UnitedHealthcare of Ohio, Inc. (the "Company") are presented on the basis of accounting practices prescribed and permitted by the Ohio Department of Insurance (the "Department").

The Department recognizes only statutory accounting practices, prescribed and permitted by the State of Ohio, for determining and reporting the financial condition and results of operations of a health maintenance organization ("HMO"), for determining its solvency under Ohio Insurance Law. The state prescribes the use of the National Association of Insurance Commissioners' ("NAIC") Accounting Practices and Procedures manual ("NAIC SAP") in effect for the accounting periods covered in the statutory basis financial statements.

No significant differences exist between the practices prescribed and permitted by the State of Ohio and those prescribed and permitted by the NAIC SAP which materially affect the statutory basis net income and capital and surplus, as illustrated in the table below:

During 2016, the Company determined that it had overstated claims adjustment expenses and general administrative expenses related to the calculation of management fees by \$3,077,698 for the year ended December 31, 2014. In addition, the federal income taxes incurred were understated by \$1,077,194 as a result of this error for the year ended December 31, 2014. Had the above adjustment been recorded to the 2014 statutory basis financial statements, the increase to net income and total capital and surplus would have been \$2,000,504, and the decrease to total assets and total liabilities would have been \$1,077,194 and \$3,077,698, respectively. In accordance with Statements of Statutory Accounting Principles ("SSAP") No. 3, *Accounting Changes and Corrections of Errors*, the correction is reported as an adjustment to unassigned surplus in the statutory basis statements of admitted assets, liabilities, and capital and surplus as of June 30, 2016.

Overpayments from CMS are reported in liability for amounts held under uninsured plans and underpayments are reported in amounts receivable relating to uninsured plans in the statutory basis statements of admitted assets, liabilities, and capital and surplus. The Company has recorded a liability of \$227,614 and \$33,060 for the CSR program as of June 30, 2016 and December 31, 2015, respectively.

The amount of Medicare Part D direct premiums written subject to this retrospectively rated feature was \$0 and \$45,987,367 representing, 0% and 6.7% of total direct premiums written as of June 30, 2016 and December 31, 2015, respectively.

The Company has risk-adjustment amounts from CMS which are subject to a redetermination feature related to Medicare premiums. The Company has estimated premium adjustments for changes to each member's health scores based on guidelines determined by CMS. The total amount of Medicare direct premiums written for which a portion is subject to redetermination features were \$0 and \$651,608,279 representing, 0% and 94.9% of total direct premiums written as of June 30, 2016 and December 31, 2015, respectively.

D. The Company is required to maintain specific minimum loss ratios on the comprehensive commercial and Medicare lines of business. The Company's actual loss ratios on the comprehensive commercial and Medicare lines of business were in excess of the minimum requirements and as a result, no minimum medical loss ratio rebate liability was required to be established at June 30, 2016 and December 31, 2015.

E. Risk-Sharing Provisions of the Affordable Care Act

(1) The Company has accident and health insurance premiums in 2016 subject to the risk-sharing provisions of the ACA.

The ACA imposed fees and premium stabilization provisions on health insurance issuers offering comprehensive commercial health insurance. The three premium stabilization programs are commonly referred to as the 3Rs – risk adjustment, reinsurance, and risk corridors.

Risk Adjustment – The permanent risk adjustment program, designed to mitigate the potential impact of adverse selection and provide stability for health insurance issuers, applies to all non-grandfathered not subject to transitional relief in the individual and small group markets both inside and outside of the insurance exchanges. Premium adjustments pursuant to the risk adjustment program are accounted for as premium subject to redetermination and user fees are accounted for as assessments.

Reinsurance – The transitional reinsurance program was designed to protect issuers in the individual market from an expected increase in large claims due to the elimination of preexisting condition limitations. The transitional reinsurance program is effective from 2014 through 2016 and applies to all issuers of major medical commercial products and third party administrators. Contributions attributable to enrollees in ACA compliant individual plans, including program administrative costs, are accounted for as ceded premium and payments received are accounted for as ceded benefit recoveries. The portion of the individual contributions earmarked for the U.S. Treasury is accounted for as an assessment. Contributions made for enrollees in fully insured plans other than ACA compliant individual plans, including program administrative costs and payments to the U.S. Treasury, are treated as assessments.

Risk Corridors – The temporary risk corridors program, designed to provide some aggregate protection against variability for issuers in the individual and small group markets during the period 2014 through 2016, applies to Qualified Health Plans in the individual and small group markets both inside and outside of the insurance exchanges. Premium adjustments pursuant to the risk corridors program are accounted for as premium adjustments for retrospectively rated contracts.

The liabilities for claims unpaid, accrued medical incentive pool and bonus amounts, aggregate health claim reserves, net of health care receivable as of December 31, 2015 was \$57,481,485. As of June 30, 2016, \$55,183,509 has been paid for incurred claims attributable to insured events of prior years. Reserves remaining for prior years, net of healthcare receivable, excluding provider loans and advances, and reinsurance recoverables are approximately \$1,628,641 as a result of re-estimation of unpaid claims. Therefore, there has been approximately \$3,926,617 favorable prior year development since December 31, 2015 to June 30, 2016. The primary drivers consist of favorable development as a result of a change in the provision for adverse deviations in experience of \$3,480,046 and provider settlement of \$2,877,922 offset by unfavorable development of \$291,276 in retroactivity for inpatient, outpatient, physician, and pharmacy claims, and of \$2,816,766 due to an increase in risk share reserves.

At December 31, 2015, the Company recorded \$12,132,510 of favorable development related to favorable development as a result of a change in the provision for adverse deviations in experience of \$4,454,859 and by favorable development of \$10,439,924 in retroactivity for inpatient, outpatient, physician, and pharmacy claims. Original estimates are increased or decreased, as additional information becomes known regarding individual claims, including the medical loss ratio rebate accruals. Included in this unfavorable development is the impact related to retrospectively rated policies, which also has a corresponding impact on medical loss ratio rebates. As a result of the prior year effects, on a regular basis, the Company adjusts revenue and the corresponding liability and/or receivable related to retrospectively rated policies and the




