B. Detail of Transactions Greater than ½% of Admitted Assets

The Company received a capital contribution of \$18,000,000 from its parent Progressive Direct Holdings, Inc., a holding company incorporated in Delaware, on August 29, 2017.

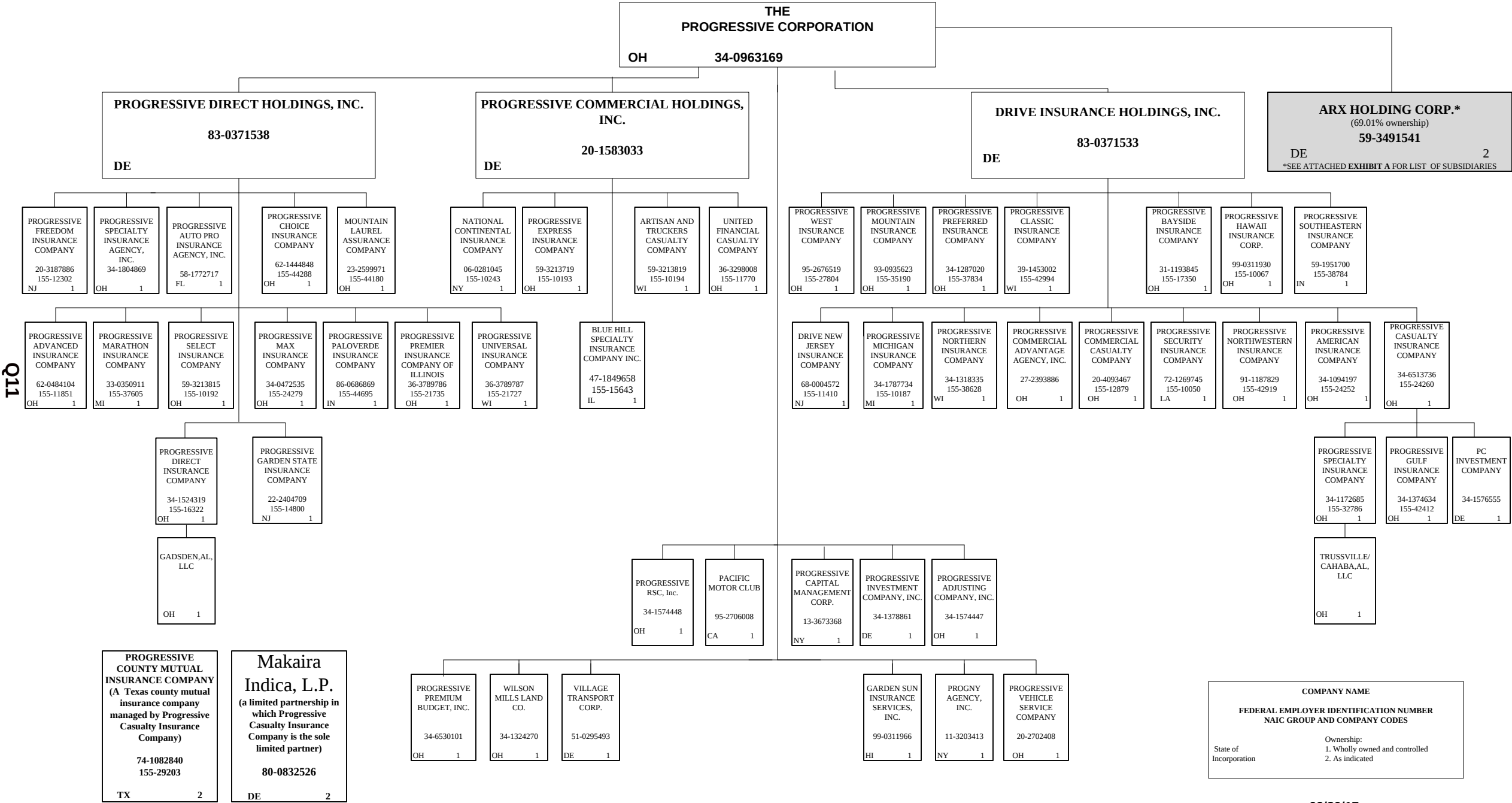

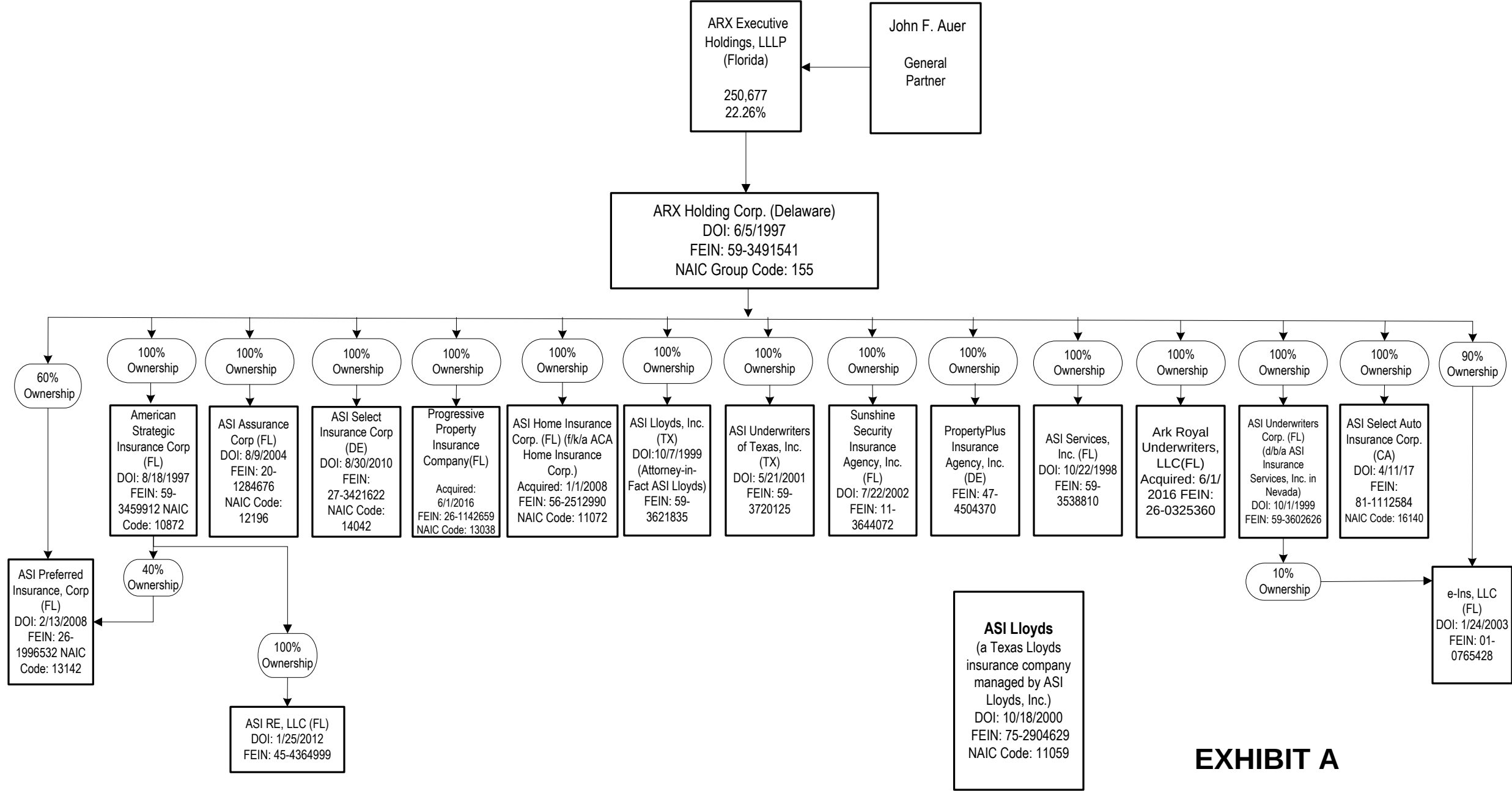
