NOTES TO FINANCIAL STATEMENTS

1. Summary of Significant Accounting Policies

- A. The financial statements of American Mutual Share Insurance Corporation (the Company) are presented on the basis of accounting practices prescribed or permitted by the Ohio Insurance Department and in accordance with NAIC Statutory Accounting Principles (NAIC SAP). All of the Company’s significant statutory accounting practices are prescribed practices.

Under three separate unused committed line of credit arrangements with three third-party financial institutions, the Company may borrow on a demand basis up to an aggregate of \$100,000,000 at an interest rate generally equal to the prevailing prime rate or LIBOR rate. Borrowings under the lines must be collateralized by investment securities and other collateral with a market value, which varies by agreement, of 103% to 125% of the amount borrowed. The Company pays annual commitment fees aggregating \$120,000 under these arrangements and one arrangement requires the Company to maintain \$1,000,000 on deposit with the financial institution. The arrangements are subject to renewal by the Company and the financial institutions on May 18, 2018 (\$70,000,000 with FHLB), on June 28, 2018 (\$10,000,000), and June 25, 2018 (\$20,000,000). The Company had no outstanding borrowings at any time under any of its committed lines of credit during 2017 and 2016.

FHLB (Federal Home Loan Bank) Advised Line of Credit Agreement: In July 2011, the Company became a member of the Federal Home Loan Bank of Cincinnati (FHLB) and purchased \$296,500 in membership capital stock. Additional membership capital stock in the amount of \$9,600, \$5,500, and \$32,600 was purchased in April 2014, 2013 and 2012, respectively, for total capital stock of \$344,200 (\$315,380 membership stock and \$28,820 excess stock) at September 30, 2017. In addition to the \$70,000,000 FHLB committed line, on October 14, 2016, the FHLB approved a one-year renewal line capacity for the Company's \$200 million "advised" line of credit, which expired October 13, 2017 and was renewed for another year to October 12, 2018. The interest rate on either of the FHLB lines varies depending upon the advance maturity term selected by the Company and can be either fixed or variable rate. Availability of the FHLB advised line, or a portion thereof, is contingent upon the Company maintaining sufficient pledged collateral at the FHLB consisting of US government agency securities and other collateral with a market value of at least 103% of the amount borrowed. At September 30, 2017, the Company has approximately \$81.5 million of US Government Agency securities pledged with the FHLB. The Company can also pledge qualifying mortgage loans towards FHLB borrowings, allowing the Company to borrow approximately 75% of the outstanding qualifying mortgage loans. The Company holds no mortgage loans at September 30, 2017. The Company is required to purchase additional FHLB stock equal to 2% of any borrowed funds. The Company had no FHLB borrowings outstanding at September 30, 2017 and December 31, 2016.

With regard to the Company's financial assets that are disclosed at a fair value, which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, the Company uses various valuation approaches, including quoted market prices and discounted cash flows. The ASC and SSAP No. 100, *Fair Value Measurement*, establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are obtained from independent sources and can be validated by a third party, whereas, unobservable inputs reflect assumptions regarding what a third party would use in pricing an asset or liability. The fair value hierarchy is broken down into three levels based on the reliability of inputs as follows:

Level 1 - Valuations based on quoted prices in active markets for identical instruments that the Company is able to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

Level 2 - Valuations based on quoted prices in active markets for instruments that are similar, or quoted prices in markets that are not active for identical or similar instruments, and model-derived valuations in which all significant inputs and significant value drivers are observable in active markets.

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

Reclassification of certain financial instruments may occur when observability of inputs change. There were no transfers between assets carried at fair value classified within Level 1 and Level 2 of the fair value hierarchy during the periods ended September 30, 2017 and December 31, 2016.

The Company evaluated all events or transactions that occurred after June 30, 2017 and through August 14, 2017, the date the financial statement were available to be issued by the Company. During this period, the Company did not have any material recognizable or non-recognizable subsequent events, except as follows:

An open guarantee commitment was settled in full in October 2017 with a payment of \$221,417, which was previously fully reserved.

As detailed below, the Company charged a special premium assessment against its primary-insured credit unions of record as of January 1, 2017 and continued to be insured as of September 30, 2017. The premium assessment is 2.5

basis points on insured shares which will generate \$3.5 million of additional revenues in the fourth quarter of 2017.

25. Changes in Incurred Losses and Loss Adjustment Expenses

The Company writes only one line of business, “Other” (with two products written solely to credit unions: primary share insurance and excess share insurance) and sets loss reserves on a prudent basis for potential claims events. Primary insurance claims can involve specifically identified claims events and other events incurred but not reported (IBNR). The Company also sets aside unallocated loss reserves for its primary insurance book of business so that aggregate loss reserves remain within an actuarially accepted range. Excess insurance claims events are infrequent (rare) but potentially severe and as a result, upon consultation with the Company’s independent actuary, the Company provides annual loss reserve additions so that cumulative loss reserves are within an actuarially accepted range.

The Company provided specific loss reserves of approximately \$32.24 million during 2009 related to two Primary-insured credit unions in Nevada, one of which was acquired by another Primary-insured credit union through a purchase and assumption (P&A) transaction that resulted in a gross claim paid of \$8,000,000 under a secondary capital note transaction. The Company transferred \$7,533,000 of guaranty loss reserves to an allowance for loss on the secondary capital note as of June 30, 2017 and December 31, 2016. As part of the guarantee agreement extension expiring September 30, 2017, the Company and the credit union entered into a partial claims settlement on September 30, 2014 in which the Company paid \$14,154,150 out of the \$20.9 million specific loss reserve at that date for this guarantee. The Company also recorded recovery income prior to 2016 of \$472,886 on the secondary capital note, primarily for interest collected that was previously fully reserved.

On September 29, 2017 the Company and the credit union entered into a final claims settlement in which the Company paid \$3,002,368, representing the approximate amount of cumulative guarantee losses not previously paid by the Company under the September 30, 2014 partial claims settlement, which was approximately \$597,000 less than the \$3,600,000 specific loss reserve held by the Company through August 31, 2017. The excess amount of case loss reserves was transferred to the Company’s unallocated bulk loss reserves at September 30, 2017. On September 29, 2017, the Company also received \$208,320 of accrued interest that was due on the secondary capital note as of September 30, 2017.

The Company had also provided \$24.6 million in the reserve for guaranty losses account at December 31, 2009 for estimated losses on a second troubled Nevada credit union. The Company determined its estimated loss at the time on this credit union through an analysis of potential losses under different events that may transpire during the workout period for this credit union, including capital assistance, merger/P&A with guarantees, liquidation and financial and operational recovery by the credit union, and the likelihood of occurrence of each identified event.

On February 12, 2010, the Company provided capital assistance to a troubled Nevada credit union, through an advance of \$22,000,000 under an SRI and an SAA as amended effective March 3, 2011, SRI-1 and the Amended SAA (see Annual Statement Note 1), which primarily provided for a five-year recovery and repayment plan through February 25, 2015, as described further below. The SRI, SRI-1, and the Amended SAA are collectively referred to herein as the SRI-1. On December 21, 2011, the Company supplemented its previously provided capital assistance with an additional \$4.4 million under a Second Amended SAA and SRI-2, collectively referred to herein as the SRI-2 (see Note 1), based on the credit union’s financial and operational progress through 2011, providing the credit union with sufficient resources to continue its recovery. The SRI-1 and SRI-2 established a plan to restore the credit union’s regulatory net worth and set a course for financial recovery by the credit union. The funds advanced to the credit union under the SRI-1 and SRI-2 were permitted to be included in regulatory net worth by the credit union’s Nevada regulatory authority and the Company’s rights to any repayment under the SRI-1 and SRI-2 are subordinated to the claims of the credit union’s members and creditors. The Amended SAA and Second Amended SAA required that the credit union comply with and operate within certain parameters designed to assist the credit union. These agreements also required that the credit union develop and implement a restructuring plan of action for 2010 and 2011, including annual updates to the restructuring plan for subsequent years, designed to enhance revenues, reduce operating costs, and implement new loan collections and other procedures in order to allow the credit union to stabilize operations, return to profitability, and to rebuild its net capital over time.

The SRI-1 divided the SRI into 10 subinstruments of \$2.2 million each, plus interest, and the original maturity date of August 11, 2010, was extended to February 25, 2015 (with maturities for the 10 \$2.2 million subinstruments beginning February 12, 2015). The SRI-1 also provided for a reduction in the interest rate under the SRI from 3.25% per annum to the two-year US Treasury rate adjusted annually on March 3 of each anniversary of SRI-1 (0.68%, 0.32%, 0.25%, 0.31%, and 0.79% effective March 3, 2015, 2014, 2013, 2012, and 2011, respectively) and required repayments against the capital assistance and interest under the SRI-1 to be made to the Company by the credit union when the credit union’s regulatory net worth to total assets (regulatory net worth ratio) exceeded 6.0%, subject to the credit union meeting certain conditions as to the level of its regulatory net worth ratio being sustained above 6.0%. The SRI-2 is structured similarly to SRI-1, with two subinstruments of \$2.2 million each, plus interest at the two-year US Treasury rate, adjusted annually on December 21 of each anniversary of SRI-2 (0.96%, 0.71%, 0.38%, and 0.26% effective December 21, 2015, 2014, 2013, and 2012, respectively), and with maturities for the two \$2.2 million subinstruments on December 30, 2016. Both SRI-1 and SRI-2 require that accrued and unpaid interest at each annual interest adjustment date be capitalized into the principal balance commencing on March 3, 2011, for SRI-1 and December 21, 2012, for SRI-2. The Company

continually evaluated the ultimate collectibility of SRI-1 and SRI-2, based on various factors, including the long-term workout period required before the credit union could be in a position to begin repayment of SRI-1 and SRI-2 and interest thereon.

SRI-1 was set to mature on February 25, 2015; however, with the credit union's good financial progress and having made six of ten SRI-1 payments aggregating \$13,200,000 (plus capitalized interest of \$635,441) through January 23, 2015, the Company and the credit union entered into an amendment to SRI-1, effective January 31, 2015, to extend the maturity date of the final four SRI-1 subinstruments to December 28, 2016. All other terms and conditions of SRI-1 remain unchanged.

In 2015, the credit union attained regulatory net worth ratios at each calendar quarter-end period, beginning March 31, 2015, and through December 31, 2015, that required the credit union to make full payments on the remaining four subinstruments of SRI-1 during the year, including payment on the estimated net realizable value for one SRI-1 subinstrument due in April 2015. As a result, the outstanding SRI-1 balance was paid in full as of October 27, 2015. Total SRI-1 payments collected in 2015, which aggregated \$13,864,957, including \$664,957 of capitalized interest, consisted of the \$6,911,814 net SRI-1 receivable and \$6,953,143 for the final three SRI-1 subinstruments. The Company reduced the allowance for loss on SRI-1 and recorded recovery income in 2015 for the same amount as the \$6,953,143 of payments collected on the final three SRI-1 subinstruments. The credit union's regulatory net worth ratio reported at December 31, 2015, required the credit union to make the two SRI-2 subinstrument payments aggregating \$4,472,165, including \$72,165 of capitalized interest, which the Company collected on January 26, 2016, resulting in the credit union fully paying off SRI-2. At December 31, 2015, the Company reduced the allowance for loss on SRI-2 by \$4,472,165 to fully recognize the SRI-2 receivable and recorded recovery income in 2015 for the same amount as the \$4,472,165 of SRI-2 payments collected in January 2016. At December 31, 2015, the Company also accrued interest due to the Company of \$1,294 for SRI-2, which was capitalized into the balance outstanding for SRI-2. The collection of all remaining amounts due under SRI-1 and SRI-2 in 2015 and through January 26, 2016, resulted in the Company's recognition of aggregate recovery income of \$11,425,308 from SRI-1 and SRI-2 in 2015.

Although the Company does not normally charge a premium under its primary insurance program, the Company's governing Ohio statute and its primary insurance policy permit premiums to be assessed against Primary-insureds in order to ensure that the Company maintains a sufficient equity base for its insurance risk. As a result of escalating risks identified in the state of Nevada in 2009, as discussed above, the Company billed its Primary-insureds a first time ever special premium assessment of \$0.15 per \$100 of each Primary-insured's total shares on December 31, 2009. This special premium assessment generated approximately \$15.2 million of revenues in 2009 but was not collected until 2010, to partially offset the primary insurance losses of over \$32 million discussed above.

On September 30, 2010, the Company again billed its Primary-insureds a special premium assessment of \$0.15 per \$100 of each Primary-insured's total shares. The special premium assessment generated approximately \$16.2 million of revenues in 2010.

On September 30, 2011, the Company billed its Primary-insureds a third special premium assessment of \$0.15 per \$100 of each Primary-insured's total shares. The special premium assessment generated approximately \$16.4 million of revenues in 2011.

On September 30, 2012, the Company billed its Primary-insureds a fourth special premium assessment of \$0.09 per \$100 of each Primary-insured's total shares. The special premium assessment generated approximately \$10.5 million of revenues in 2012.

On September 30, 2013, the Company billed its Primary-insureds a fifth special premium assessment of \$0.075 per \$100 of each Primary-insured's total shares. The special premium assessment generated approximately \$9.0 million of revenues in 2013.

As a result of the repayments of the previously fully reserved Special Reserve Instrument (described above) the Company did not assess a special premium assessment from 2014 through 2016. Because of continuing suppressed interest market rates, the Company charged a special premium assessment in 2017 of \$0.025 per \$100 of each Primary-insured's total shares or 2.5 basis points. The special premium assessment has been recorded as a receivable at October 31, 2017 in the aggregate amount of \$3.5 million which also generates \$3.5 million of additional revenues in the fourth quarter of 2017.

Since the Company has no specific excess insurance loss events identified at September 30, 2017, for which a loss reserve would normally be established, all of the Company's loss reserves related to excess insurance and its unallocated primary insurance loss reserves are treated as unallocated IBNR loss reserves. For purposes of Schedule P, in any given year the cumulative unallocated IBNR loss reserves held are considered to have occurred as follows: (1) 60% in current year; (2) 30% in the previous year; and (3) 10% in the second previous year and have been allocated as such in Schedule P, which is comparable to methods used by other insurance companies with infrequent claims events. Since claims events are rare (infrequent but potentially severe), the typical year shows favorable development. A summary of the favorable loss development for the Company's single line of business ("Other") for 2017 and a reconciliation of loss provision, claims payments, prior year loss development and gross losses incurred in 2017, follows (dollars in thousands):

The Company provides deposit insurance to participating credit unions under the Company's primary and excess contracts. Under the primary insurance contract, a deposit of 1.3% of the member's year-end share balance is required. These capitalization deposits are non-interest bearing and the investment earnings therefrom are used to fund the Company's deposit insurance programs in lieu of a normal premium charge. Special Premium Assessments may be charged from time to time against insured credit unions to fund claims activity during unusual times, such as in 2009 – 2013 and in the fourth quarter of 2017, in order to maintain the insurance fund at a regulatory acceptable primary insurance equity ratio (currently the equity ratio is approximately 1.67% of primary insurance fund equity to primary insured shares). Even so, the deposits for the primary and excess deposit contracts are at-risk to the insured credit unions and ultimately can act as a reserve that is available to pay claims if needed. The aggregate of capitalization deposits that are available to pay claims are \$183,034,042 at September 30, 2017. Therefore, the Company has determined there is not a need for a premium deficiency reserve and none has been recorded at September 30, 2017. This evaluation was completed on October 30, 2017. The Company considers investment income when evaluating the need for premium deficiency reserves.

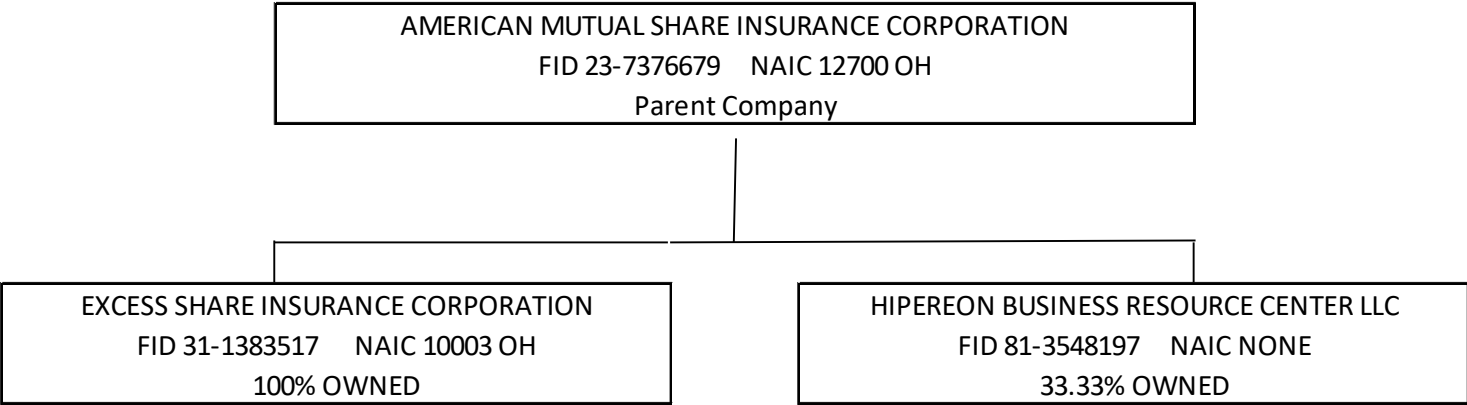
