A. Accounting Practices

The financial statements of Excess Share Insurance Corporation (the Company, or ESI) are presented on the basis of accounting practices prescribed or permitted by the Ohio Insurance Department and in accordance with the NAIC Statutory Principles (NAIC SAP). All of the Company's significant statutory accounting practices are prescribed practices.

(6) Federal Income Taxes – The Company files a Federal income tax return separate from its Parent. Total income taxes of \$284,638 were paid during 2017 (none in 2018).

The Company accounts for deferred income taxes using the asset and liability method, which requires the recognition of deferred tax assets and liabilities for the expected future tax consequences of events that have been included in the financial statements. Deferred tax assets that are not anticipated to be realized within three years are treated as non-admitted assets in the accompanying statutory-basis financial statements. All of the Company's deferred tax assets (\$491,500 at March 31, 2018 and December 31, 2017, relating primarily to its reserve for guaranty losses) are treated as non-admitted assets.

Based upon its evaluation of relevant conditions and events, management does not have substantial doubt about the Company's ability to continue as a going concern.

We believe it is more likely than not that our deferred tax assets will be realized and have therefore recorded no valuation allowance as of March 31, 2018. Significant factors we considered in determining the probability of realizing the deferred tax benefits include our historical operating results, the amount of our loss carryback potentials, and the expectations of future earnings. On December 22, 2017 the President of the United States signed the Tax Cuts and Jobs Act, which enacted various tax law changes, including a reduction of the corporate tax rate from 35% (34% for the Company) to 21% effective January 1, 2018. While this will reduce future current federal income taxes beginning in 2018, the tax law change also reduces corporate gross deferred tax assets (DTAs) and deferred tax liabilities (DTLs) effective December 31, 2017 since SSAP No. 101—Income Taxes requires that DTAs and DTLs be computed using enacted tax rates expected to apply to taxable income in the periods in which the DTA or DTL is expected to be settled or realized. As a result, the Company's DTAs were reduced by \$280,800 (net) at December 31, 2017 to reflect the new 21% corporate tax rate. Had the tax law not been enacted, the Company would have reported a \$23,400 increase in DTAs using the 34% corporate tax rate in effect. The Company has no DTLs.

Level 2 - Valuations based on quoted prices in active markets for instruments that are similar, or quoted prices in markets that are not active for identical or similar instruments, and model-derived valuations in which all significant inputs and significant value drivers are observable in active markets.

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

Reclassification of certain financial instruments may occur when observability of inputs change. There were no transfers between assets carried at fair value classified within Level 1 and Level 2 of the fair value hierarchy during the periods ended March 31, 2018 and December 31, 2017.

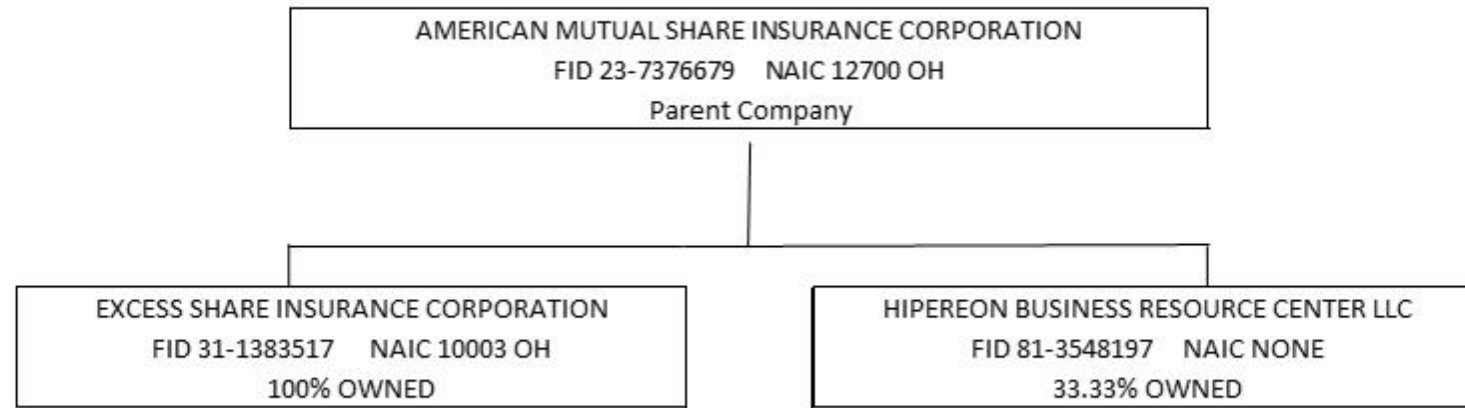
