The Company routinely assesses the collectibility of premiums and agents' balances receivable and records a bad debt reserve for amounts exceeding the nonadmitted balance that the Company believes are uncollectible.

The Company is named as defendant in various lawsuits arising out of its insurance operations. All legal actions relating to claims made under insurance policies are considered by the Company in establishing its loss and LAE reserves. The Company also has potential exposure relating to lawsuits due to its participation in a management agreement for which it is allocated litigation expenses.

There was a lawsuit alleging that as a result of the alleged fraud of an independent insurance agency, the Company should be liable to a premium finance company for its losses relating to fraudulent financed policies.

There was a putative class action lawsuit challenging the Company's procedures related to the rejection of uninsured/underinsured motorist coverage.

Commercial auto liability developed unfavorably primarily due to originally anticipated severity for accident year 2016 increasing by 1.2% and accident years 2017 and 2015 and prior increasing by less than 1%. LAE reserves developed unfavorably in both defense cost and containment reserves and adjusting and other reserves. Defense cost and containment reserves developed unfavorably primarily due to higher than anticipated defense counsel spend, while adjusting and other reserves developed unfavorably due to higher than anticipated claims expenses.

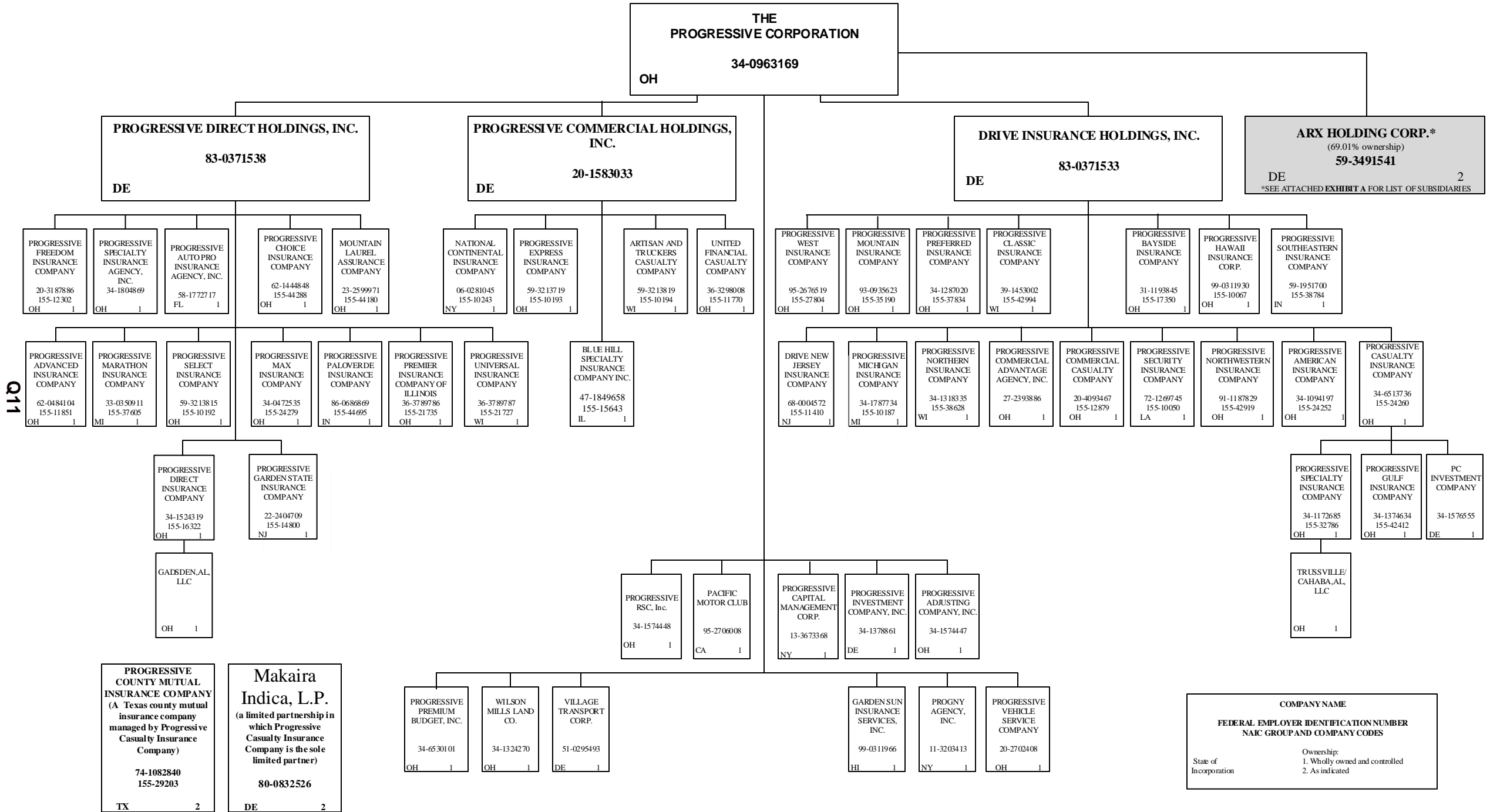
