10. INFORMATION CONCERNING PARENT, SUBSIDIARIES AND AFFILIATES

A. Relationship with Parent, Subsidiaries and Affiliates:

On June 4, 2018, the Company announced a plan to convert its corporate structure to a Mutual Holding Company structure. Through this conversion, the Company’s parent, Grange Mutual Casualty Company (GMCC) will become a stock company and change its name to Grange Insurance Company (GIC). GIC and its wholly-owned subsidiaries will be owned by a new holding company, Grange Holdings, Inc. 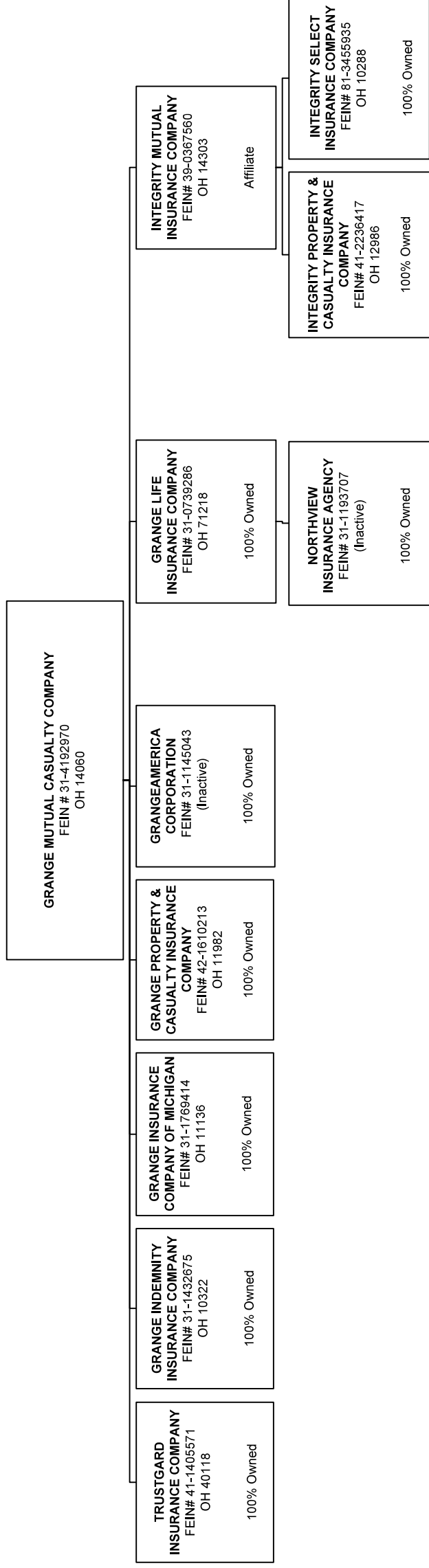
