10. INFORMATION CONCERNING PARENT, SUBSIDIARIES AND AFFILIATES

A. Relationship with Parent, Subsidiaries and Affiliates:

1. On June 4, 2018, the Company announced a plan to convert its corporate structure to a Mutual Holding Company structure. Through this conversion, the Company's parent, Integrity Mutual Insurance Company (IMICO) will become a stock company and change its name to Integrity Insurance Company (IIC). IIC and its wholly-owned subsidiaries will be owned by a new holding company, Grange Holdings, Inc. (GHI), which will be 100% owned by a new mutual holding company, Grange Mutual Holding Company (GMHC). The conversion plan was approved by the policyholders of GMCC (Grange Mutual Casualty Company) and IMICO on July 19, 2018 and is subject to approval by the Ohio Department of Insurance. 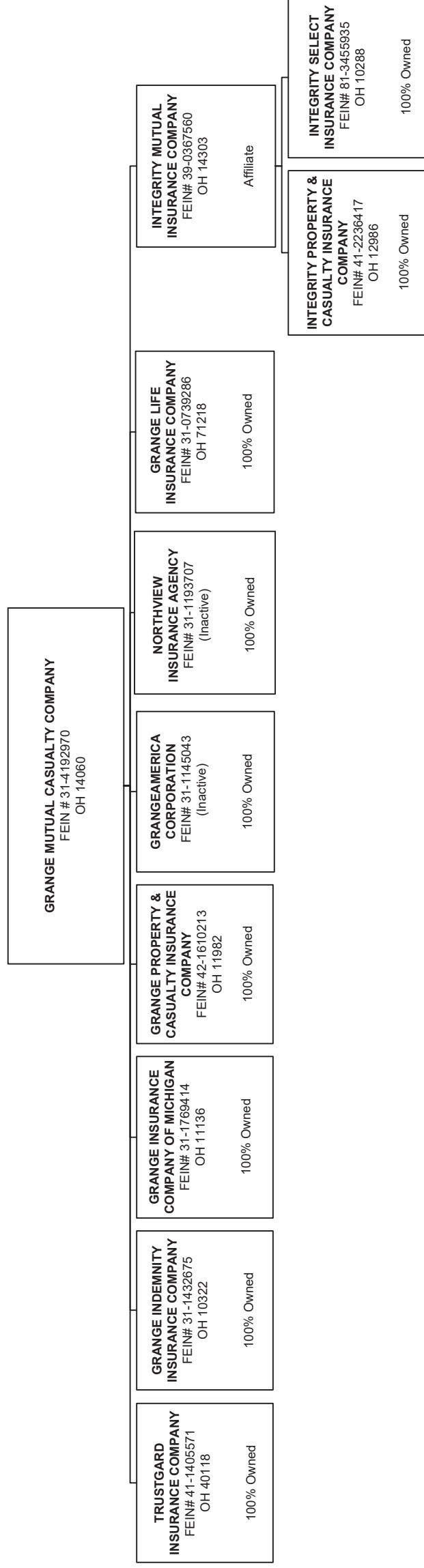
