Incurred losses and LAE attributable to insured events of prior accident years decreased by \$464,225 in 2019, which is less than 1% of the total prior year net unpaid losses and LAE of \$79,755,276. The favorable development is primarily due to commercial auto liability originally anticipated severity decreasing by 6.8% for accident year 2017 partially offset by private passenger auto liability originally anticipated severity increasing by 3.1% for accident year 2018. LAE reserves developed favorably in total. Defense and cost containment reserves developed favorably due to lower than anticipated attorney costs, while adjusting and other expense reserves developed unfavorably due to higher than anticipated claims costs.

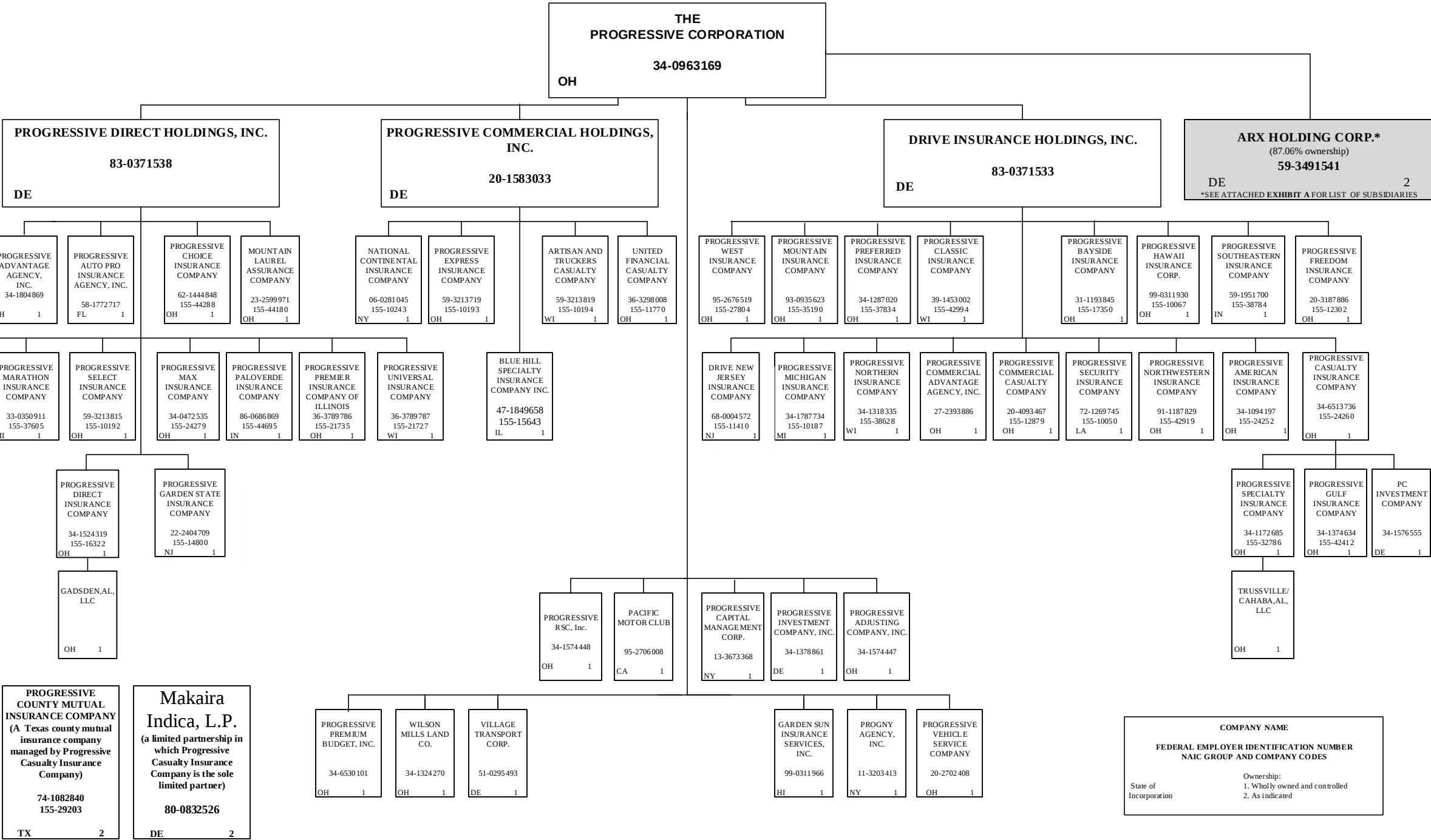

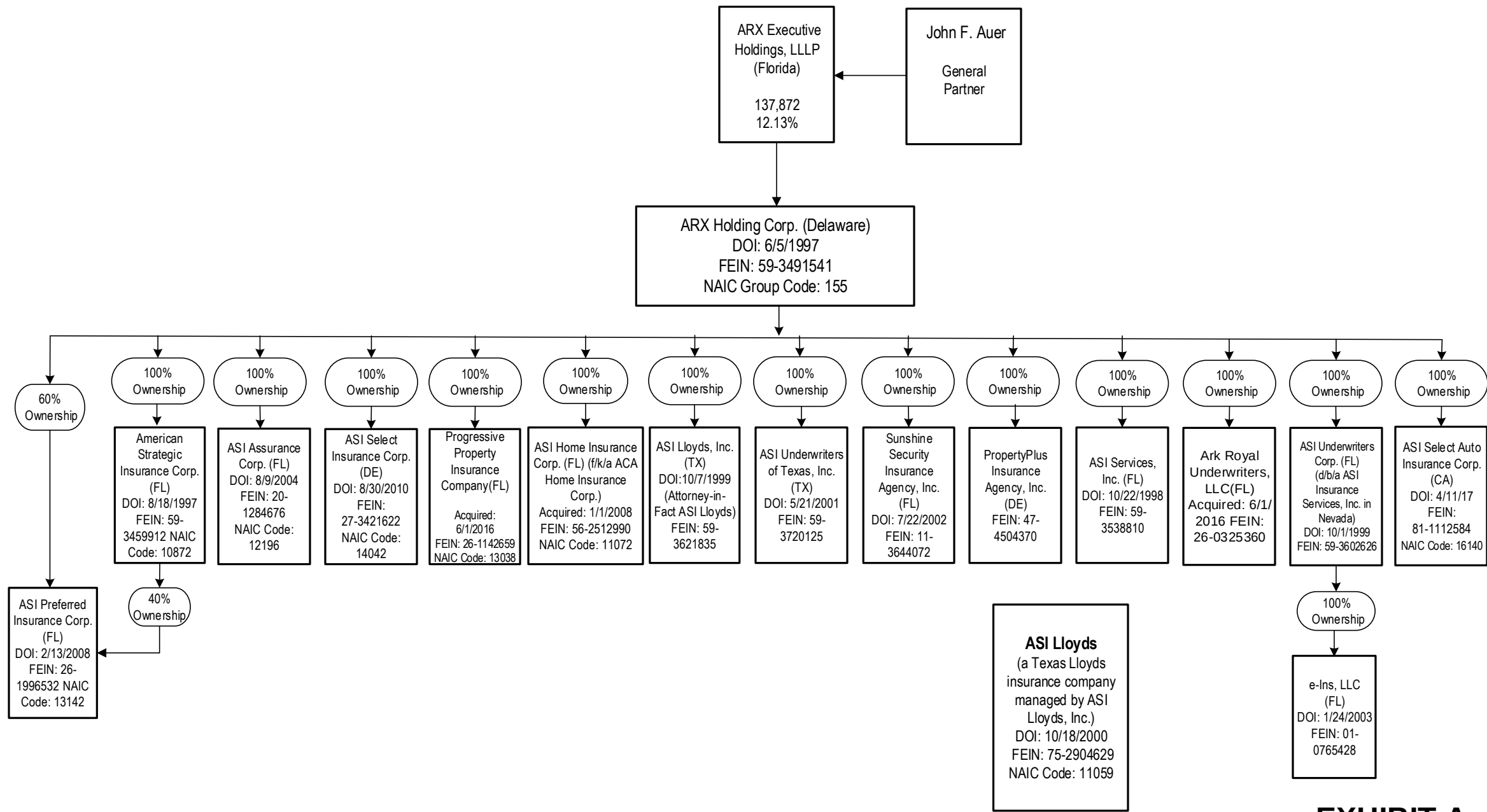
