Reserves remaining for prior years are now \$11.7 million and \$0.2 million as a result of the reestimation of unpaid claims and claim adjustment expenses. Therefore, there has been \$31.1 million in favorable prior-year development. This decrease is generally the result of ongoing analysis of recent loss development trends.
