Incurred losses and LAE attributable to insured events of prior accident years increased by \$4,459,424 in 2019, which is 1.2% of the total prior year net unpaid losses and LAE of \$376,857,080. The unfavorable development is primarily due to private passenger auto liability originally anticipated severity increasing by less than 1% for accident year 2018. LAE reserves developed unfavorably in total primarily due to higher than anticipated attorney costs.

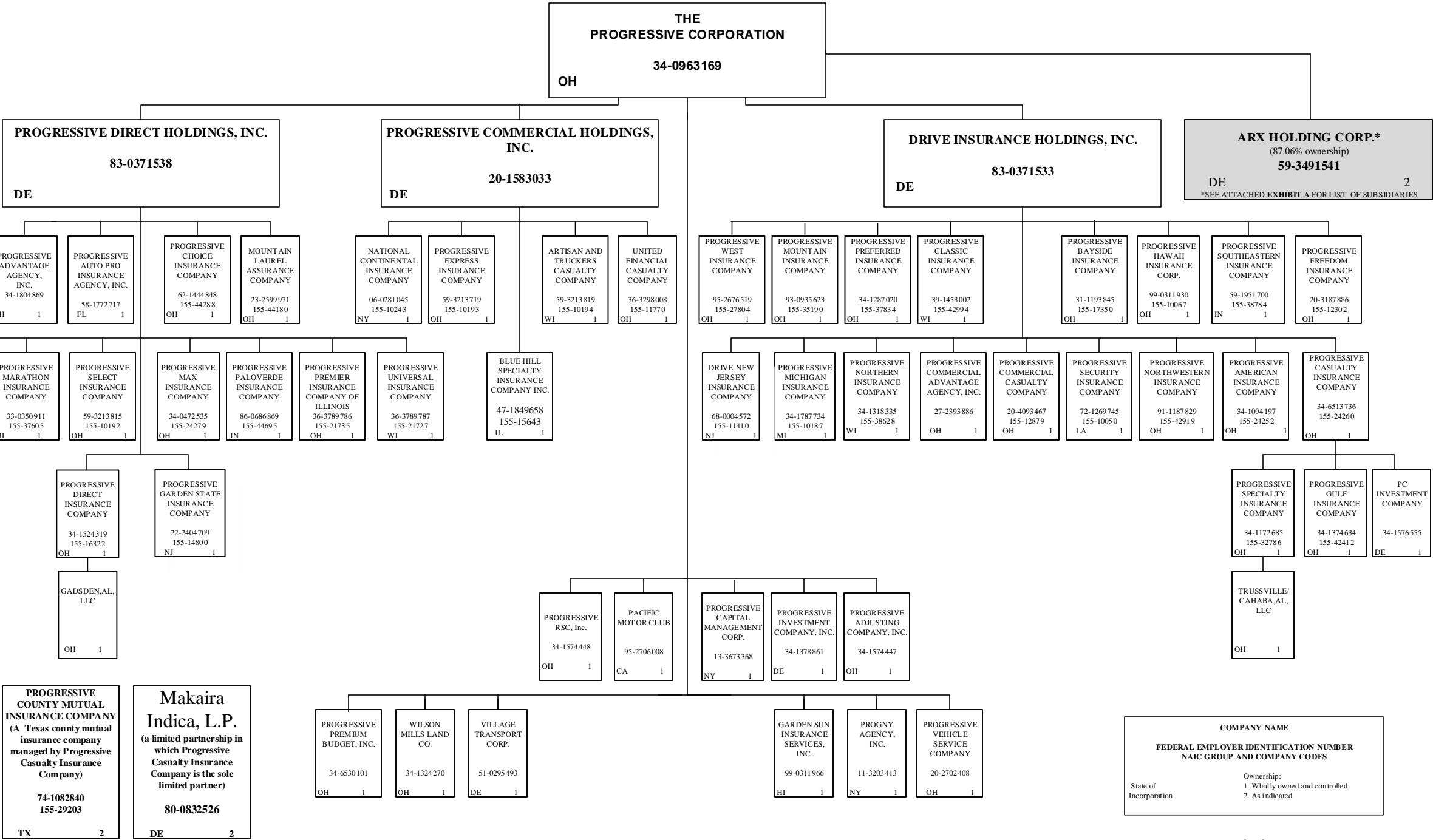

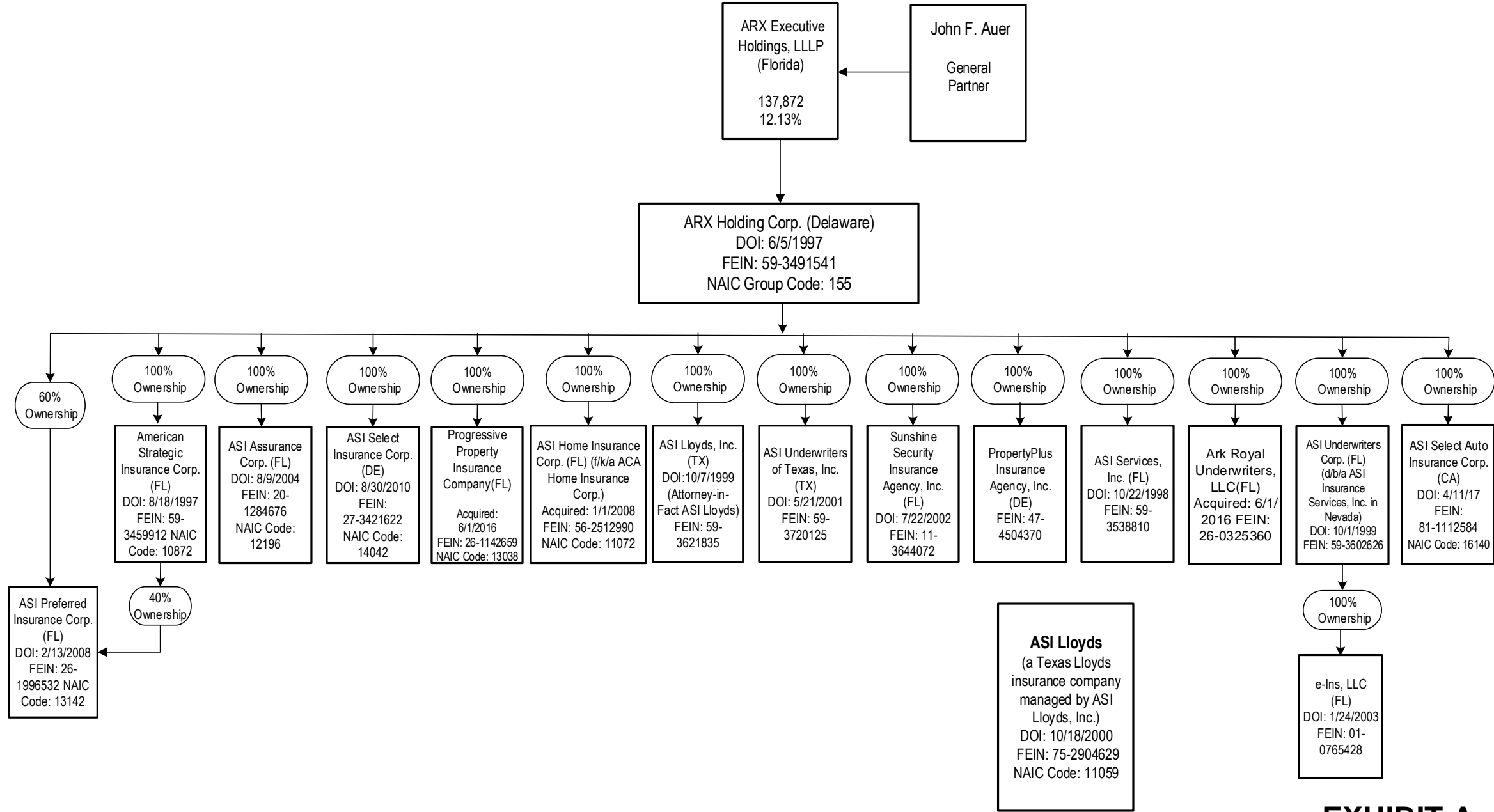
