The Company also has a capitation arrangement with Aultman Hospital for anticipation of future services. As of June 30, 2019, the Company has paid \$2,710,000 Aultman Hospital for these future services.

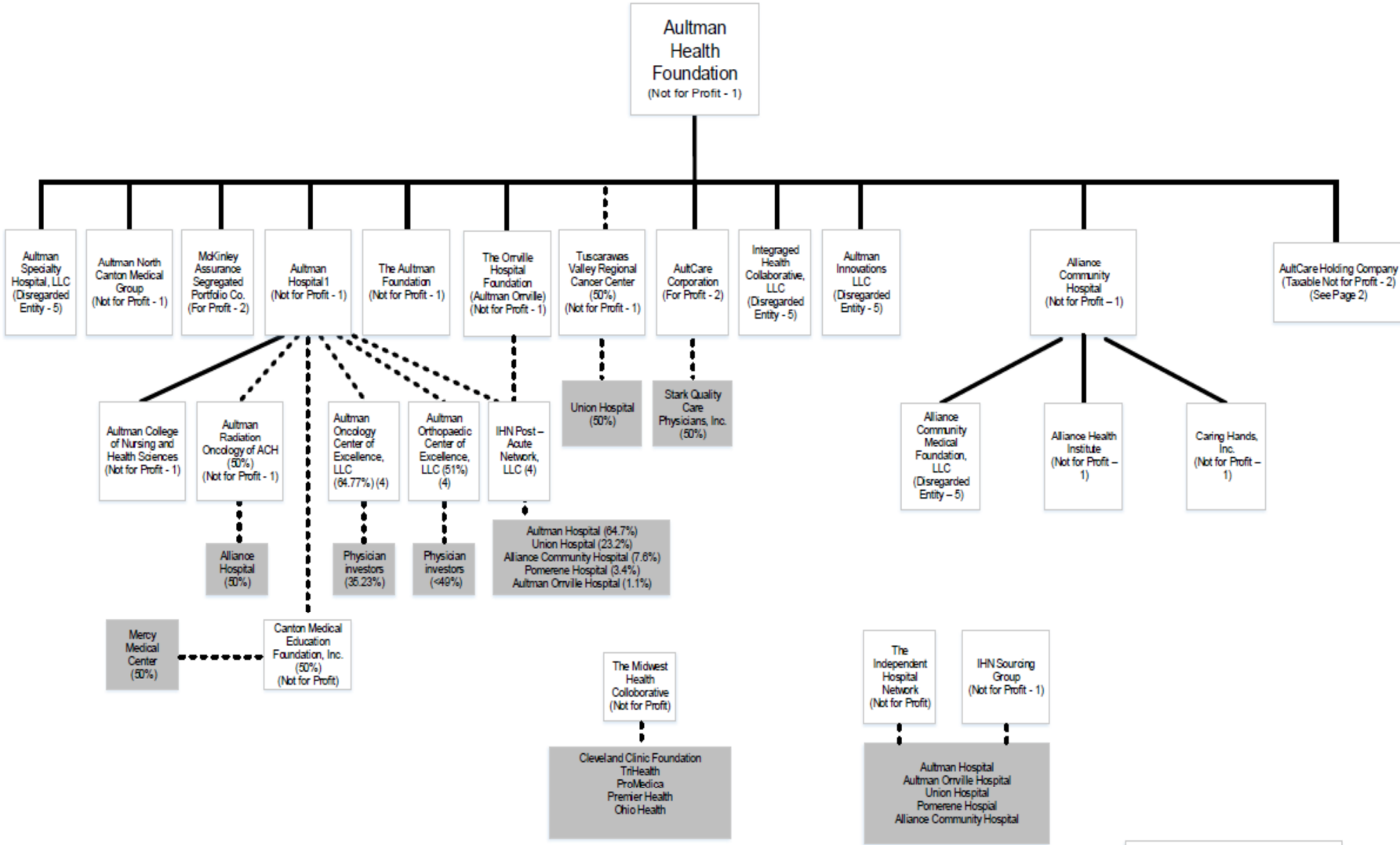

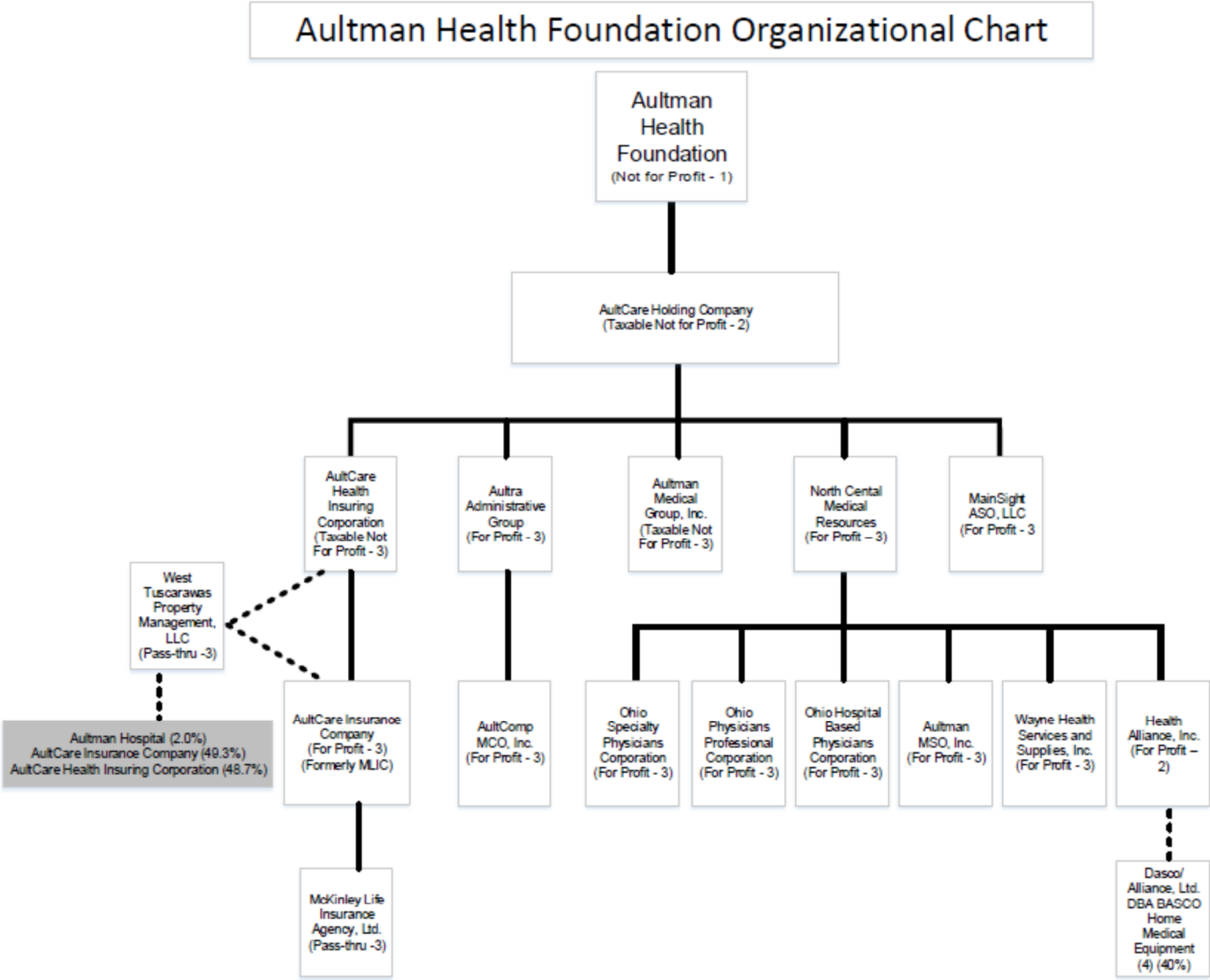
