Under SSAP No. 43R, the Company analyzes its structured debt securities to determine if the Company intends to sell, or if it is more likely than not that the Company will be required to sell, the security prior to recovery and, if so, the Company writes down the security to its current fair market value with the entire amount of the write-down recorded as a realized loss. Incurred losses and LAE attributable to insured events of prior accident years decreased by \$1,071,837 in 2019, which is 1.3% of the total prior year net unpaid losses and LAE of \$79,755,276. The favorable development is primarily due to commercial auto liability originally anticipated severity decreasing by 8.8% for accident year 2017 partially offset by private passenger auto liability originally anticipated severity increasing by 3.5% for accident year 2018. 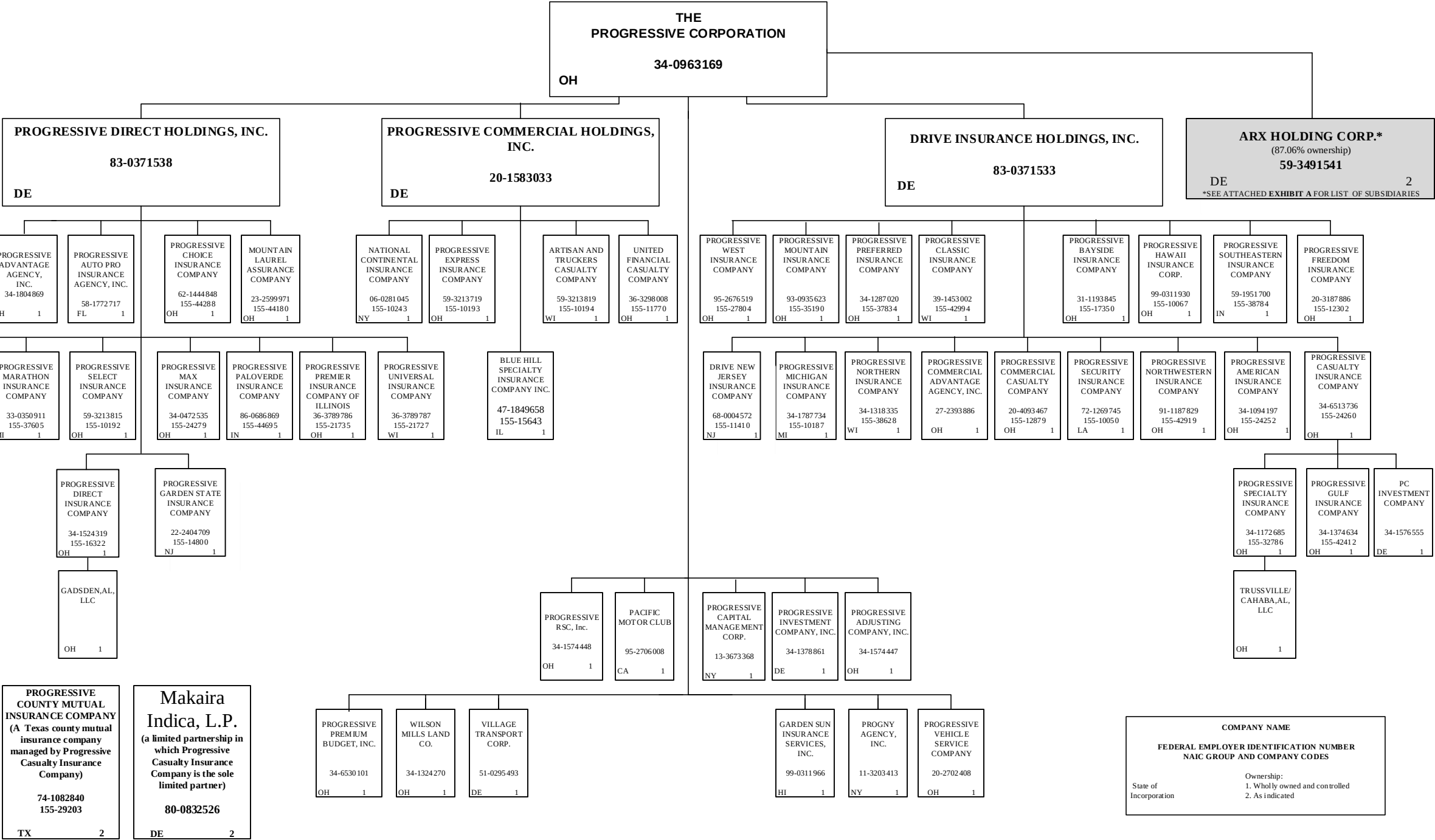

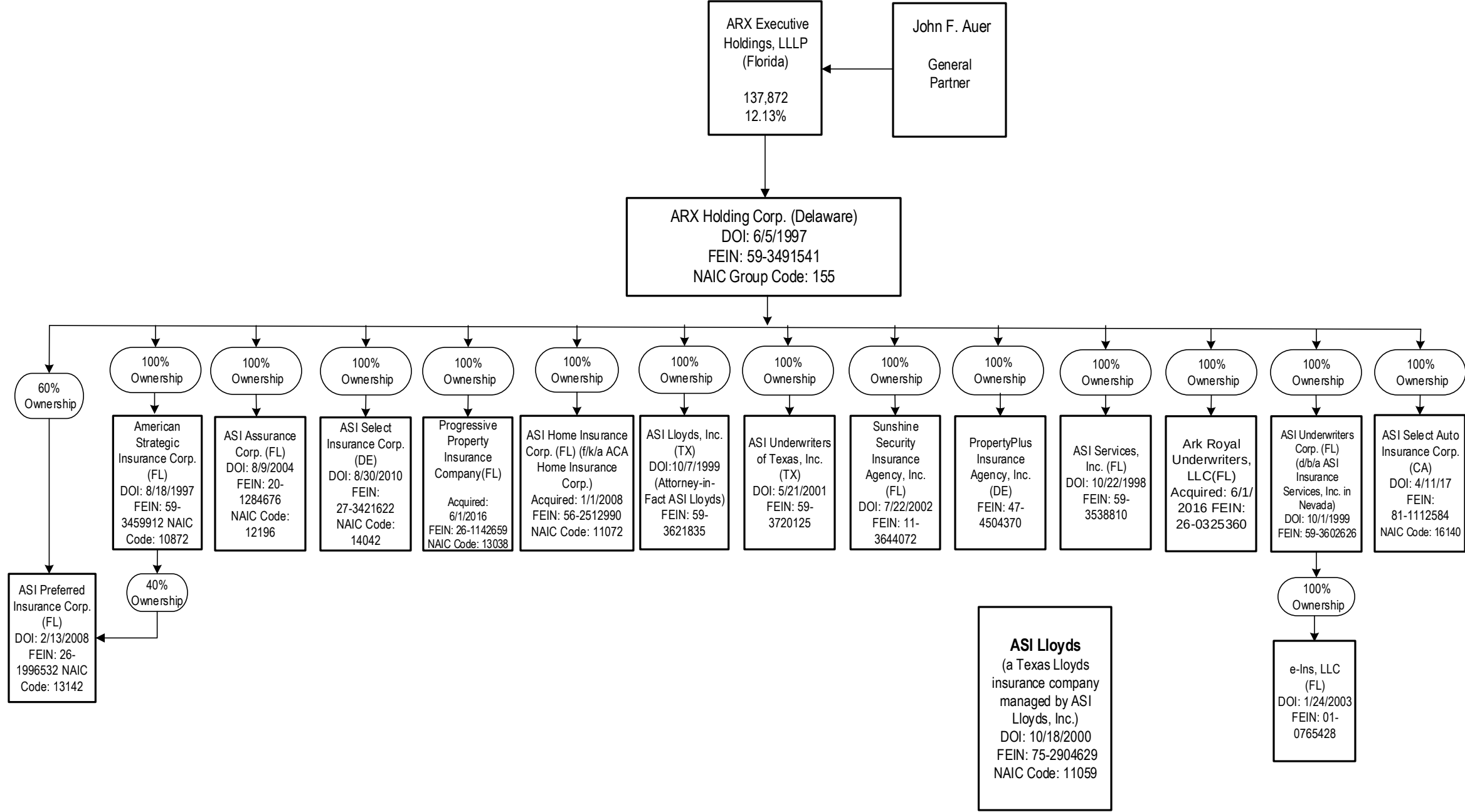
