The Company is named as defendant in various lawsuits arising out of its insurance operations. The Company also has, on a net basis, potential exposure relating to lawsuits due to its participation in a 100% pooling reinsurance agreement for which it is allocated litigation expenses.



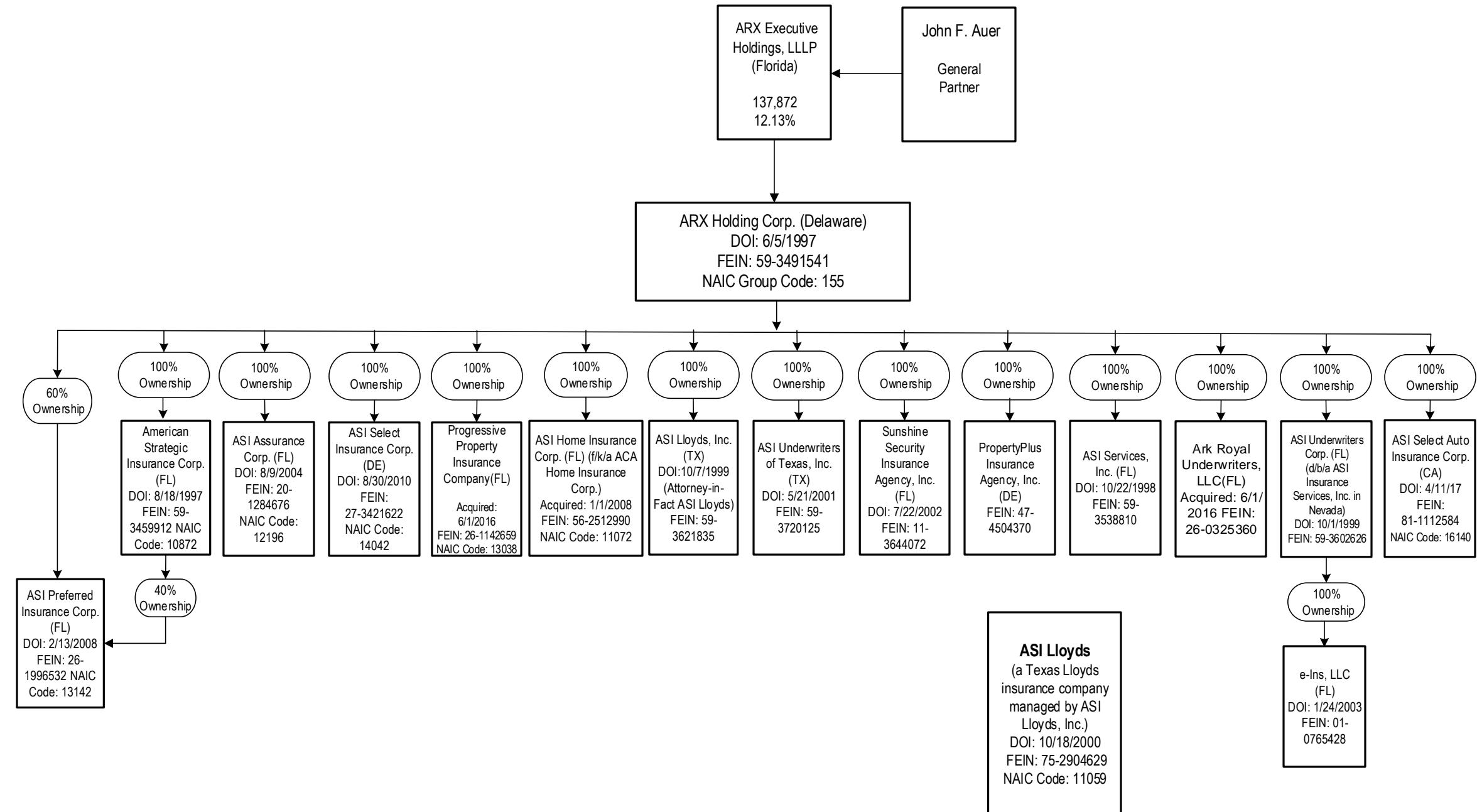
