The Commissioner of Insurance has the right to permit other specific practices that deviate from prescribed practices.

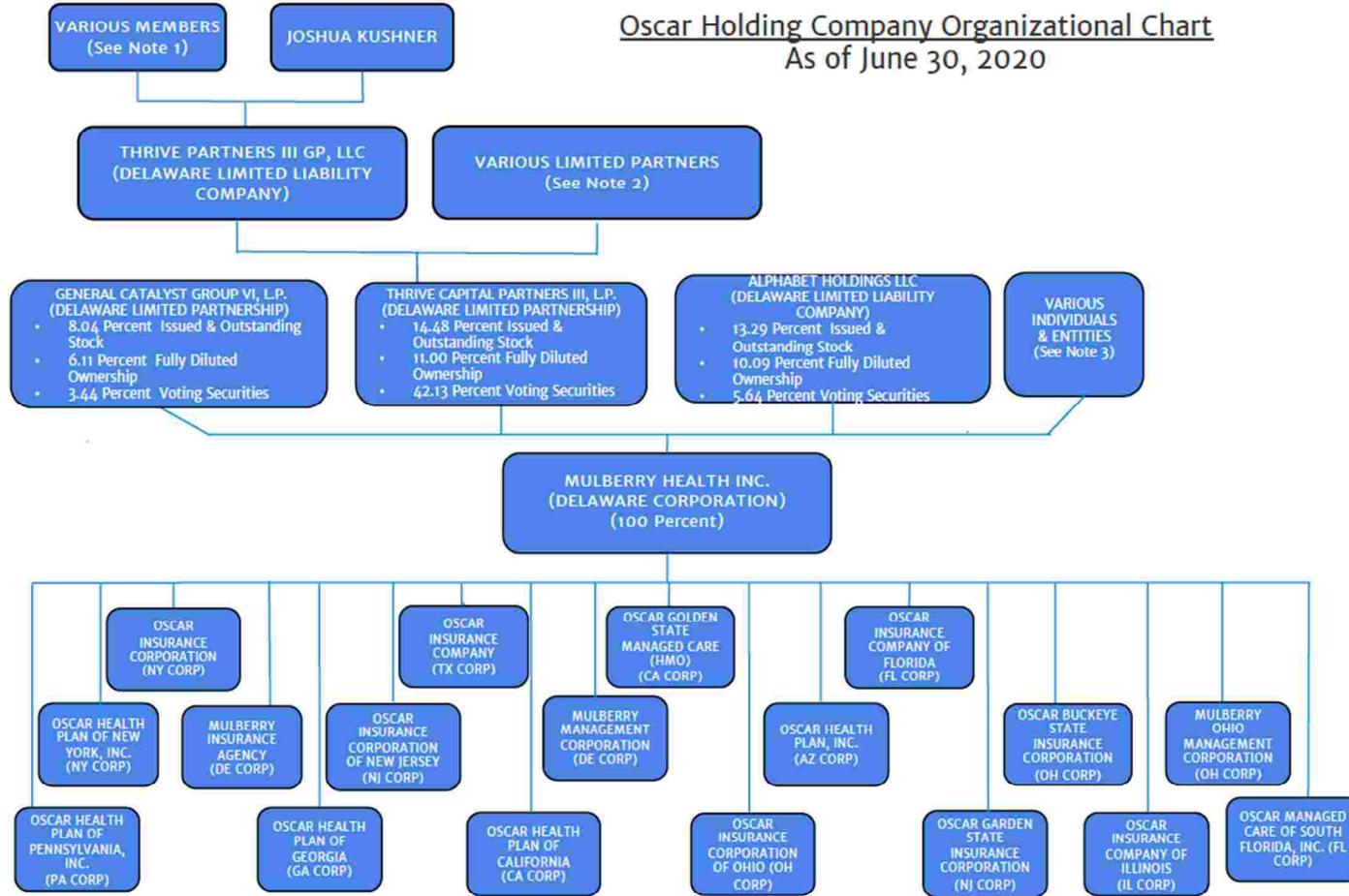
