Note 1 – Summary of Significant Accounting Policies and Going Concern

A. Accounting Practices
The financial statements of Transport Insurance Company ("the Company") are presented on the basis of accounting practices prescribed or permitted by the Ohio Department of Insurance.

The Ohio Department of Insurance recognizes only statutory accounting practices prescribed or permitted by the state of Ohio for determining and reporting the financial condition and results of operations of an insurance company, for purposes of determining its solvency under the Ohio Insurance Law. In our most recent analysis, the year end December 31, 2020 cash and invest assets balance, excluding restricted balances pledged as statutory deposits, along with the remaining balance on the NICO cover (on a paid basis) were compared with the claims payments patterns plus a \$3m annual load for overhead. That analysis shows that the Company has the ability to continue as a going concern beyond one year from the financial statement issuance date.
