23. Reinsurance

During 2021, the Arrangement was subject to a quota share reinsurance agreement with Medical Mutual of Ohio to cede 90% of the Arrangement's health business.

During 2021, the Arrangement was subject to a stop loss reinsurance agreement with Medical Mutual of Ohio for medical and prescription drug coverage. The premium is based upon the monthly funding rates and number of participants in each month of the contract. The specific stop loss threshold per covered person is \$250,000 for 2021. The aggregate threshold is 125% of expected aggregate claims.
