B. The Company participates in the Pension Plan for Insurance companies (PPIO) who are responsible for managing the Company's pension plan assets. All investment decisions are made at the discretion of PPIO in accordance with their policies. Once money is contributed to the Plan, the money is invested by plan officials called fiduciaries. Specific investments are made in accordance with the Plan's investment policy. The investment policy of the Plan is to limit the impact of capital market fluctuations on the plan by investing in a mix of assets that aligns with the plan's liability profile. The total portfolio is expected to be less volatile than the market the vast majority of the time. The plan assets are invested in a mix of equity and fixed income investments subject to target allocation ranges. The target allocation range for domestic equity investments is 30% and 50%. The target allocation range for fixed income investments is between 50% and 70%. The target allocation range for international equity investments is between 0% and 10%. Remaining funds not invested in the categories above are to be invested in short-term cash equivalents such as money market funds. Target allocation ranges are guidelines, not limitations, and occasionally the Named Fiduciaries will approve allocations above or below a target range.

The plan assets are invested in various classes including U.S. equity securities, foreign equity securities, fixed income (debt) securities, and cash. Market values are used to measure the fair value of plan assets. To the best of our knowledge, PPIO does not invest in any assets that would need to be measured using significant unobservable inputs (Level 3). PPIO has not identified that there are any significant concentrations of risk within the plan assets.
