Original estimates are increased or decreased as additional information becomes known regarding individual claims. The 03/31/2022 reserves are \$4,484 or 22.8% higher than the 12/31/2021 reserve.

The liability for unpaid accident and health claims and claim adjustment expenses represents the Company's best estimate with a margin; however, there may be future adjustments to this estimate and related assumptions. Such adjustments, reflecting any variety of new and adverse trends, could possibly be significant and result in increase in liabilities. 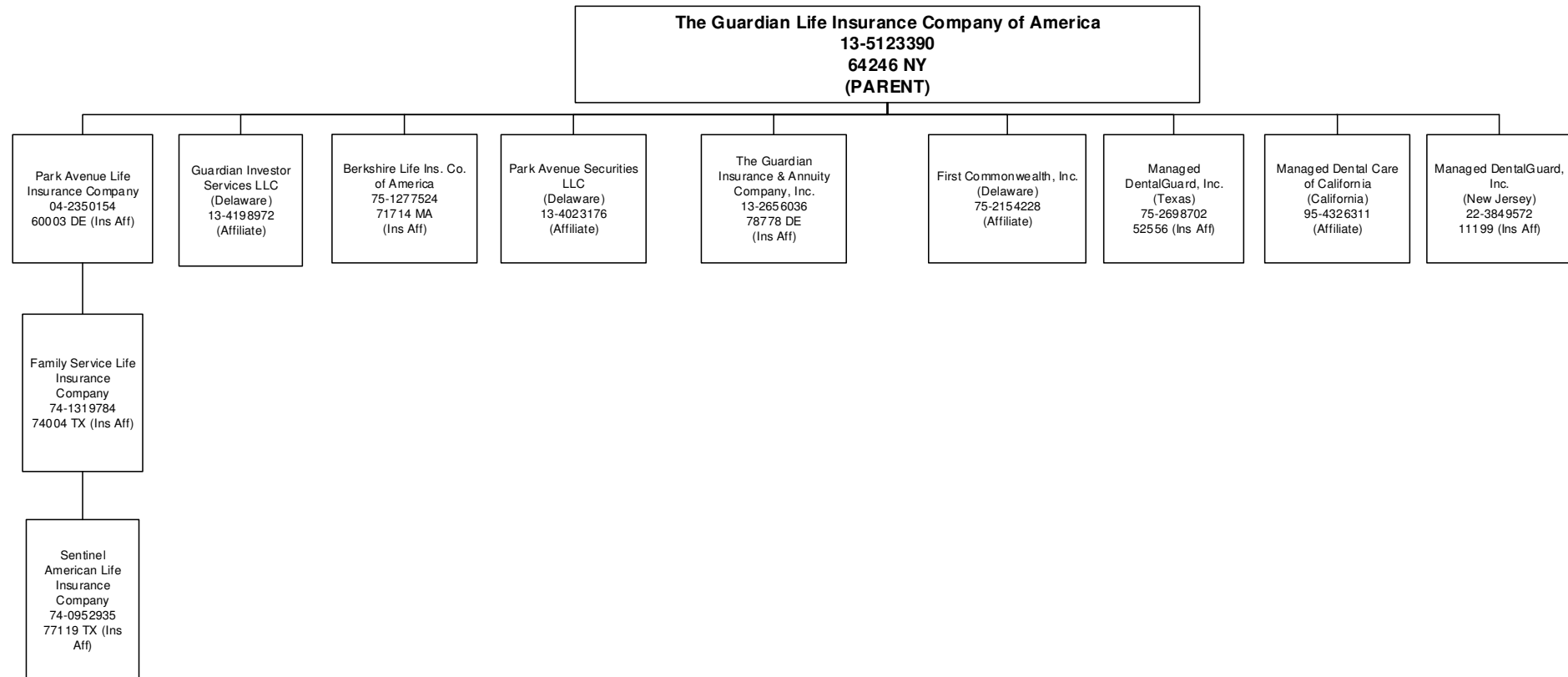

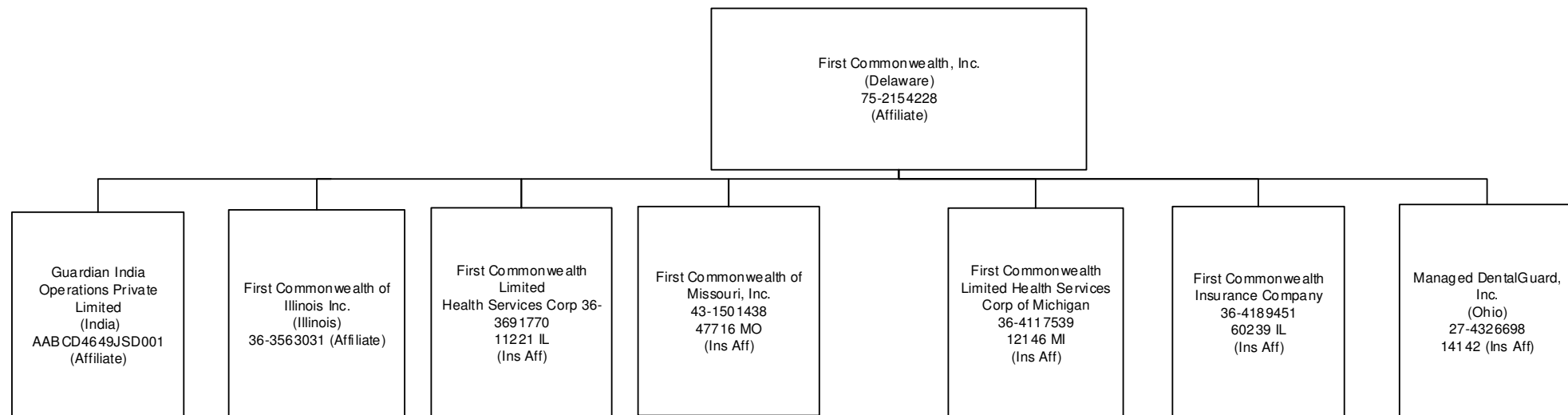

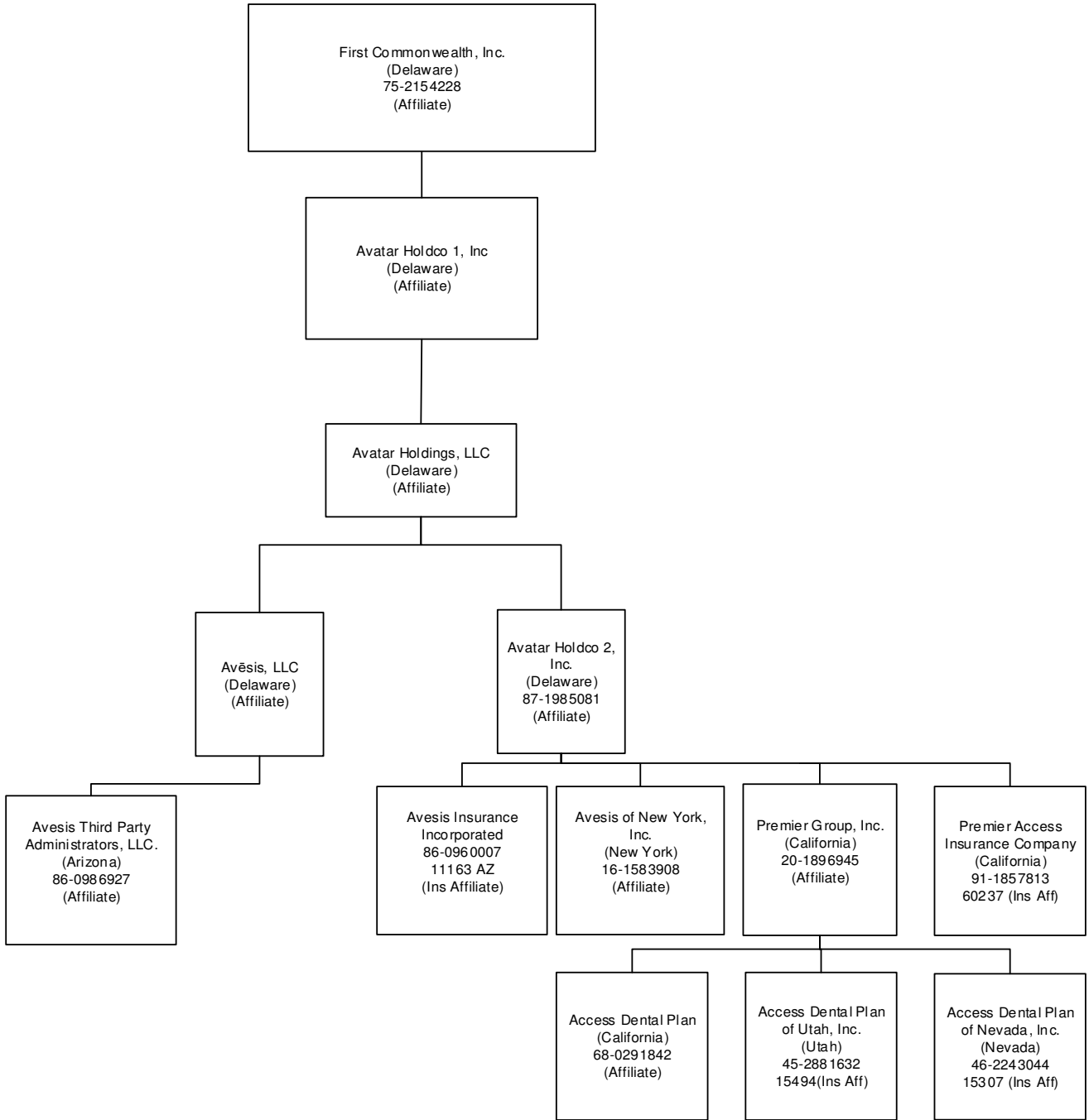
