Subsequent events have been considered through August 12, 2022 for these statutory financial statements which are to be issued on August 15, 2022.

23. Reinsurance

During 2022, the Plan was subject to a quota share reinsurance agreement with Medical Mutual of Ohio to cede 90% of the Plan's health business.
