CoSECTION A

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Accounting Practices

The accompanying financial statements of AultCare Health Insuring Company are presented on the basis of accounting practices prescribed or permitted by the Ohio Department of Insurance.

The Ohio Department of Insurance recognizes only statutory accounting prescribed or permitted by the State of Ohio for determining and reporting the financial condition and results of operations of an insurance company, for determining its solvency under the Ohio Insurance Law. The National Association of Insurance Commissioners’ (NAIC) Accounting Practices and Procedures manual, (NAIC SAP) has been adopted as a component of prescribed or permitted practices by the state of Ohio.

The Company also is a party to a Management and Administrative Services Agreement with AultCare Corporation under which AultCare Corporation provides the Company with certain specified services, including (among others) management and administrative services, provider networking services, marketing and sales services, and office facilities. The Company paid AultCare Corporation \$13,260,364 and \$14,334,804 respectively, for services provided under the Management and Administrative Services Agreement as of September 30, 2022 and 2021, respectively.

D. The Company has an intercompany revolving credit facility in place with AultCare Corporation, a subsidiary. The Company is owed \$ 2,402,715 and \$1,830,387 as of September 30, 2022 and September 30, 2021, respectively.

The Company has an intercompany revolving credit facility in place with AultCare Corporation, an affiliate that allows AultCare to borrow and repay operating funds. As of September 30, 2022 and 2021, AultCare Corporation does not owe any funds under the terms of this agreement.

The Company also has a capitation arrangement with Aultman Hospital for anticipation of future services. As of September 30, 2022, the Company has paid Aultman Hospital \$5,742,617 for these future services.

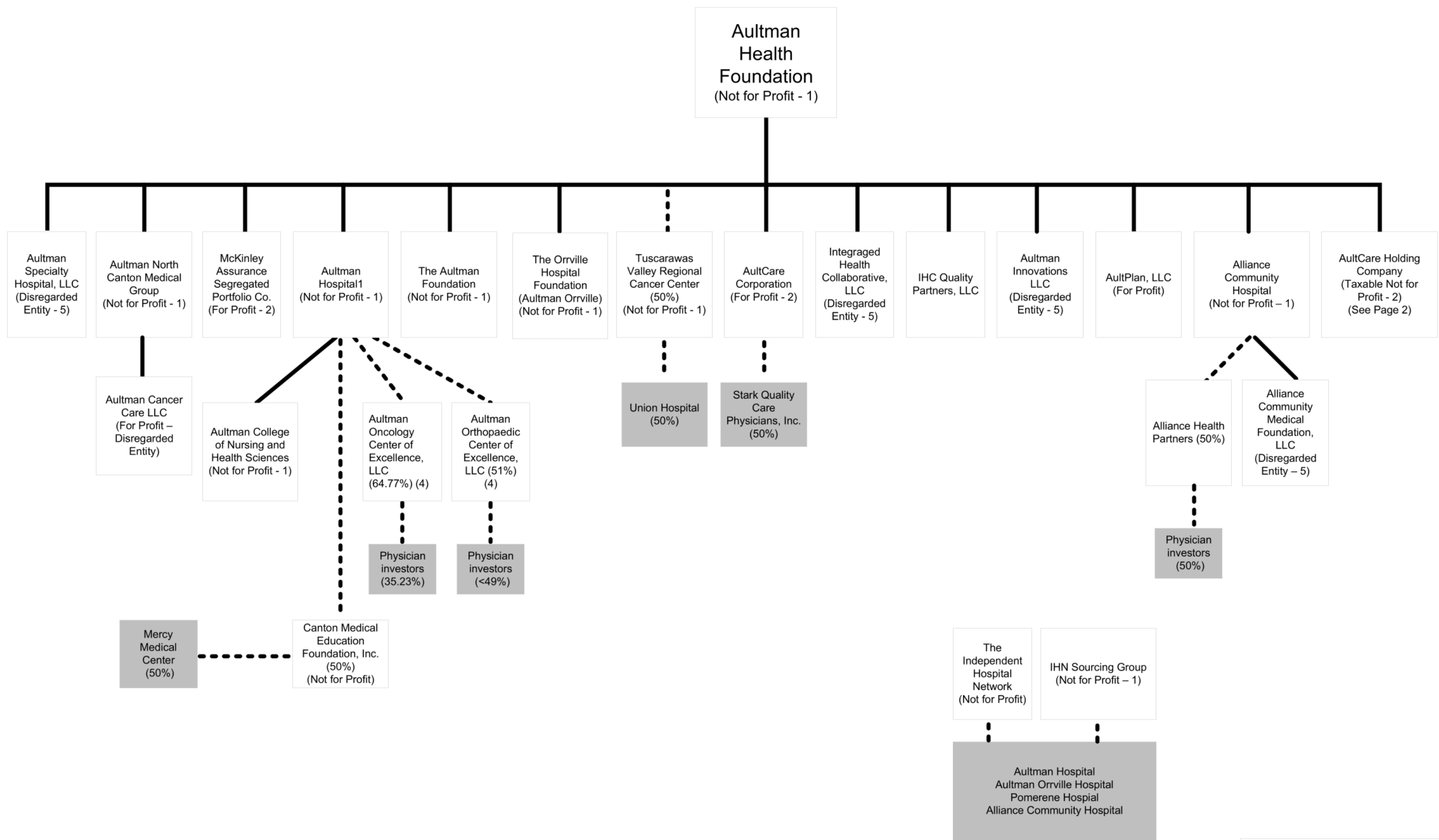

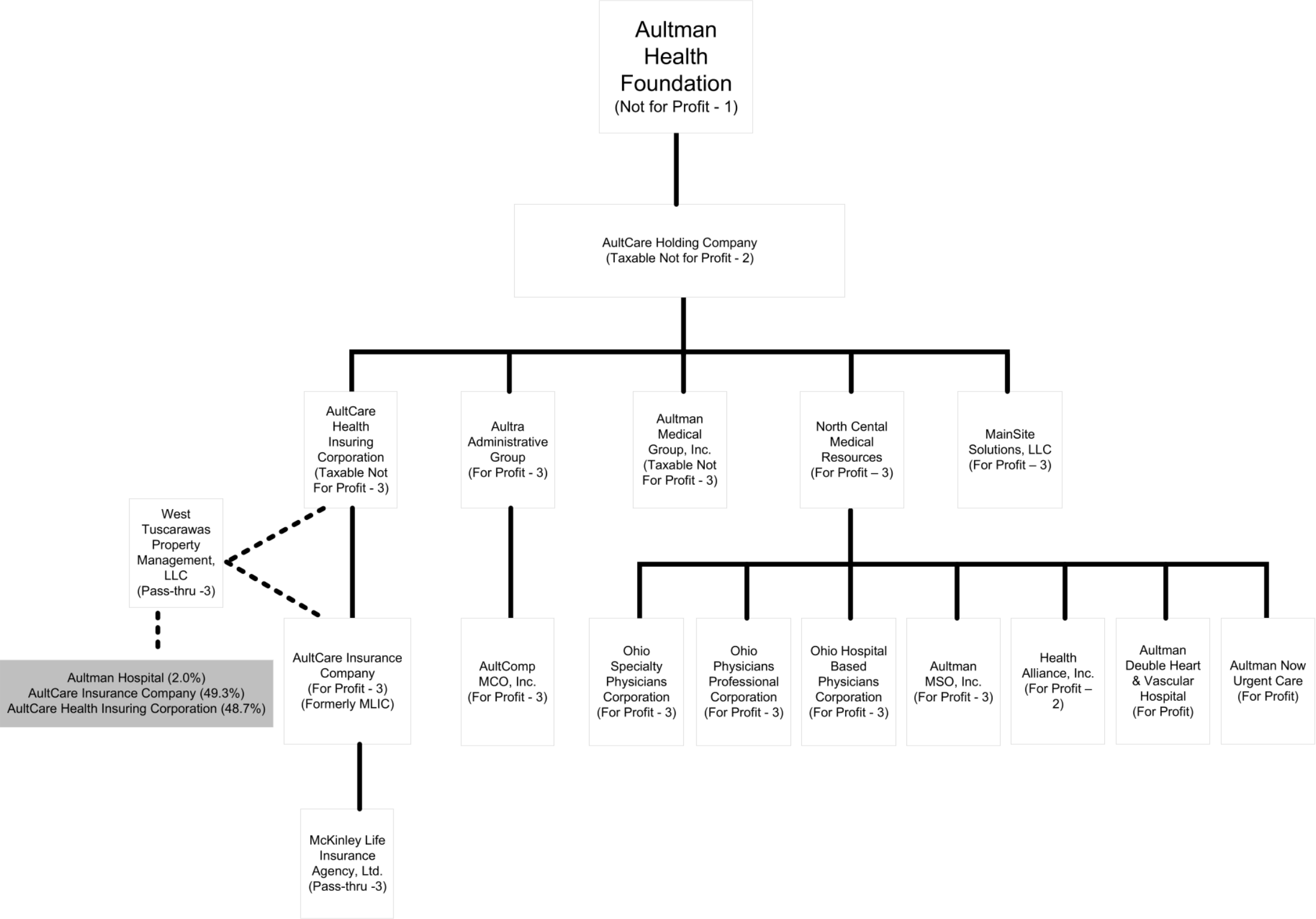
