The difference between the original cost and redemption value of these securities is recognized over the lives of the respective issues and included in net investment gain.

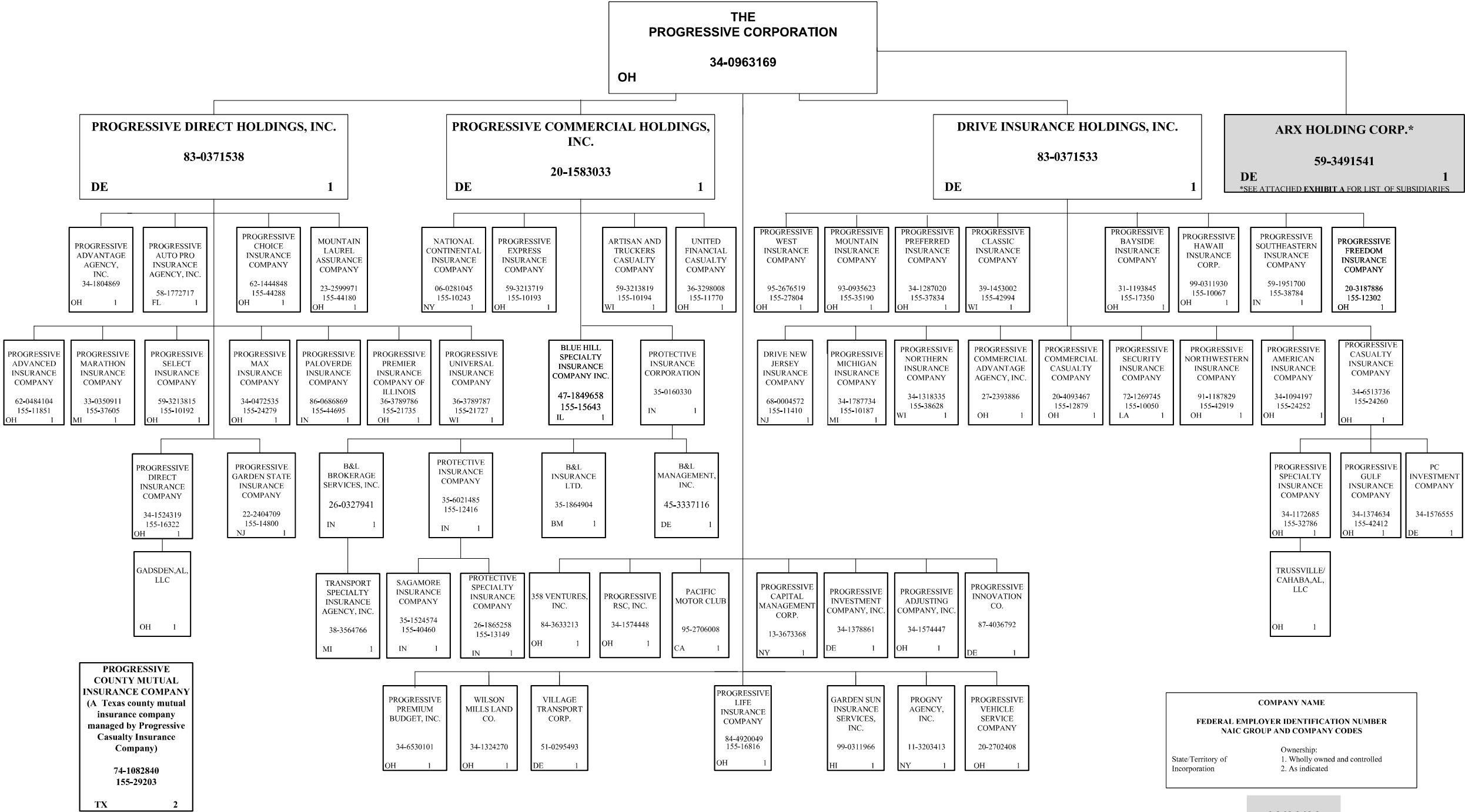

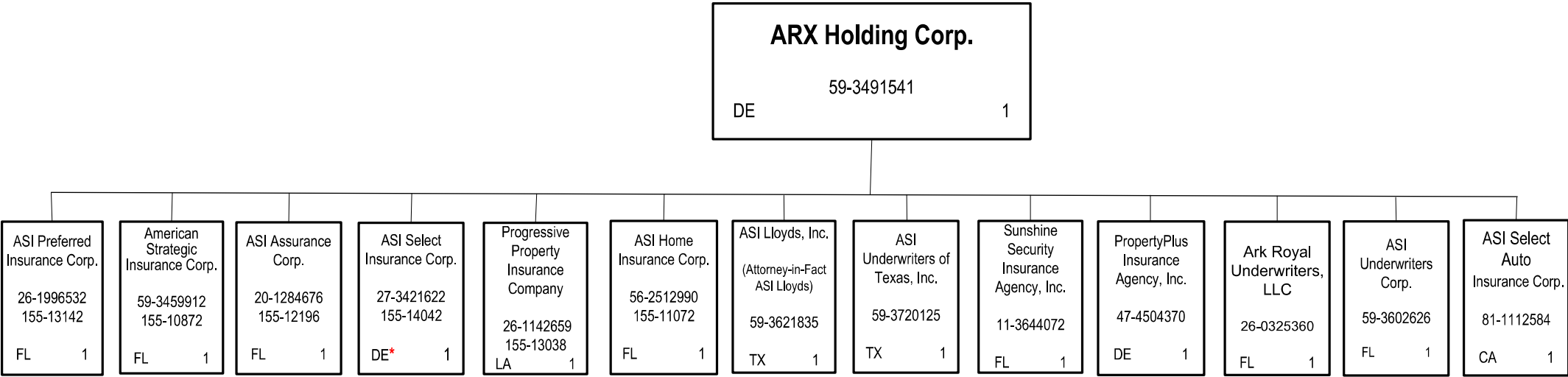

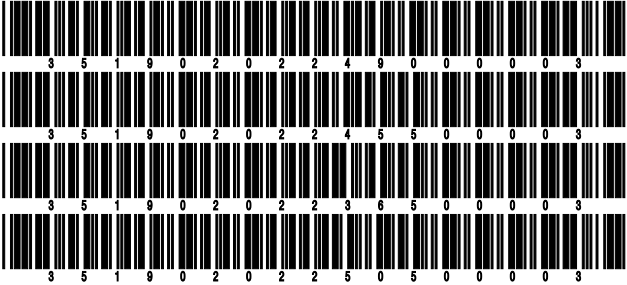
