For a group of related entities, the \$1 billion threshold is determined on a group basis.

A corporation's tentative CAMT liability is equal to 15% of its adjusted financial statement income and is payable to the extent the tentative CAMT liability exceeds regular corporate income tax. Any CAMT paid would be indefinitely available as a credit carryover that could reduce future regular tax in excess of CAMT.

The controlled group of corporations of which the Company is a member has not determined as of the reporting date if it will be subject to the CAMT in 2023. The third quarter 2022 financial statements do not include the estimated impact of the CAMT, because a reasonable estimate cannot be made.
