NOTES TO FINANCIAL STATEMENTS

NOTE 1   Summary of Significant Accounting Policies and Going Concern

A.   Accounting Practices  
The financial statements of Westfield Touchstone Insurance Company (the Company) are presented on the basis of accounting practices prescribed or permitted by the Ohio Department of Insurance.

B.   Use of Estimates in the Preparation of the Financial Statements  
The preparation of financial statements in conformity with SAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities. C.   Accounting Policy  
Premiums are earned over the terms of the related insurance policies and reinsurance contracts. Unearned premium reserves are established to cover the unexpired portion of premiums written. Such reserves are computed by pro rata methods for direct business and are based on reports received from ceding companies for reinsurance.

Expenses incurred in connection with acquiring new insurance business, including such acquisition costs as sales commissions, are charged to operations as incurred. Expenses incurred are reduced for ceding allowances received or receivable.

The reinsurance broker, Aon, models the insured exposures on the Company's behalf.
