The Company does not employ accounting practices that depart from the NAIC SAP.

B. Use of Estimates in the Preparation of the Financial Statements

Expenses incurred in connection with acquiring new insurance business, including such acquisition costs as sales commissions, are charged to operations as incurred. Expenses incurred are reduced for ceding allowances received or receivable.
