NOTE 1 Summary of Significant Accounting Policies and Going Concern

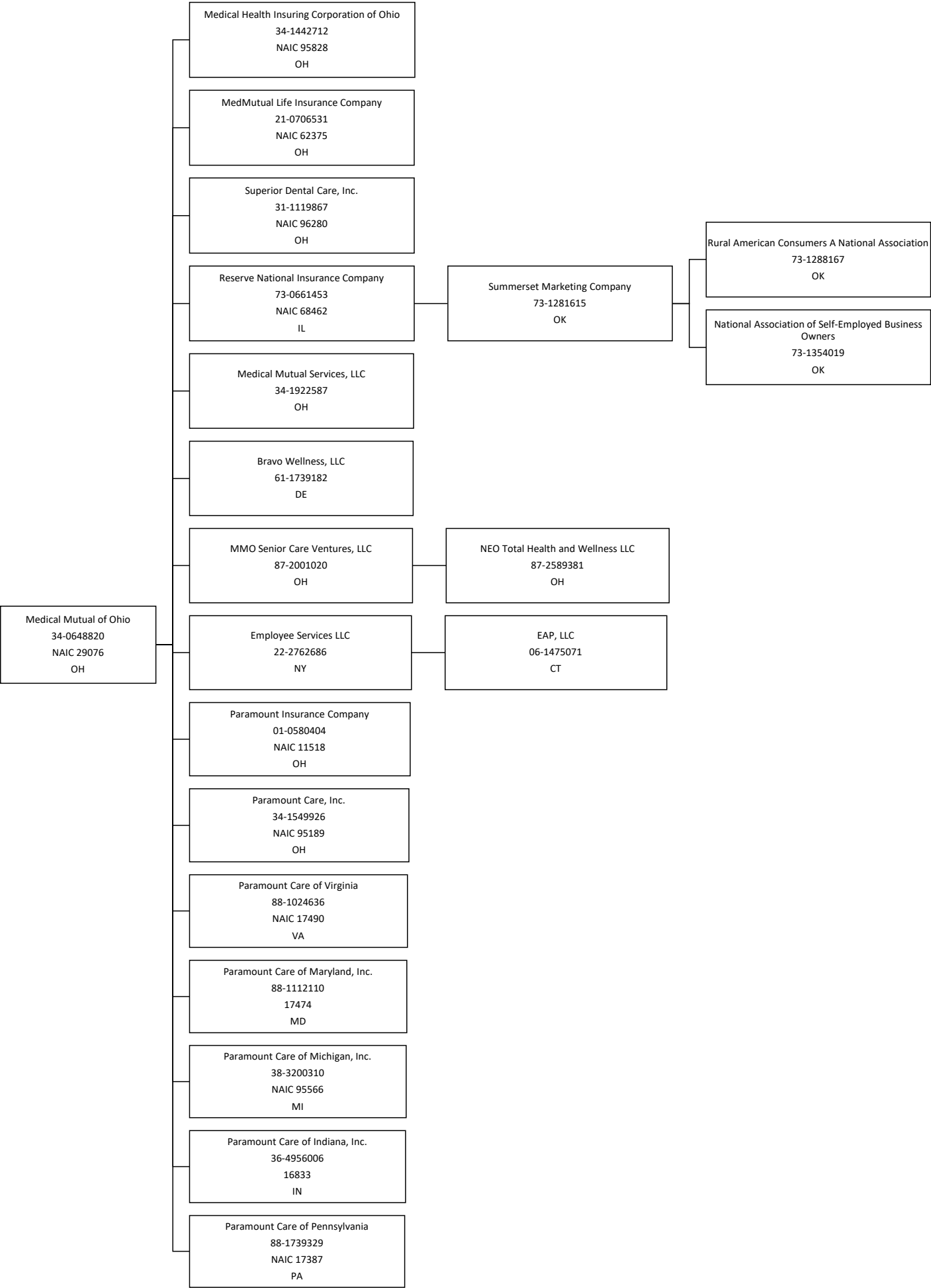
