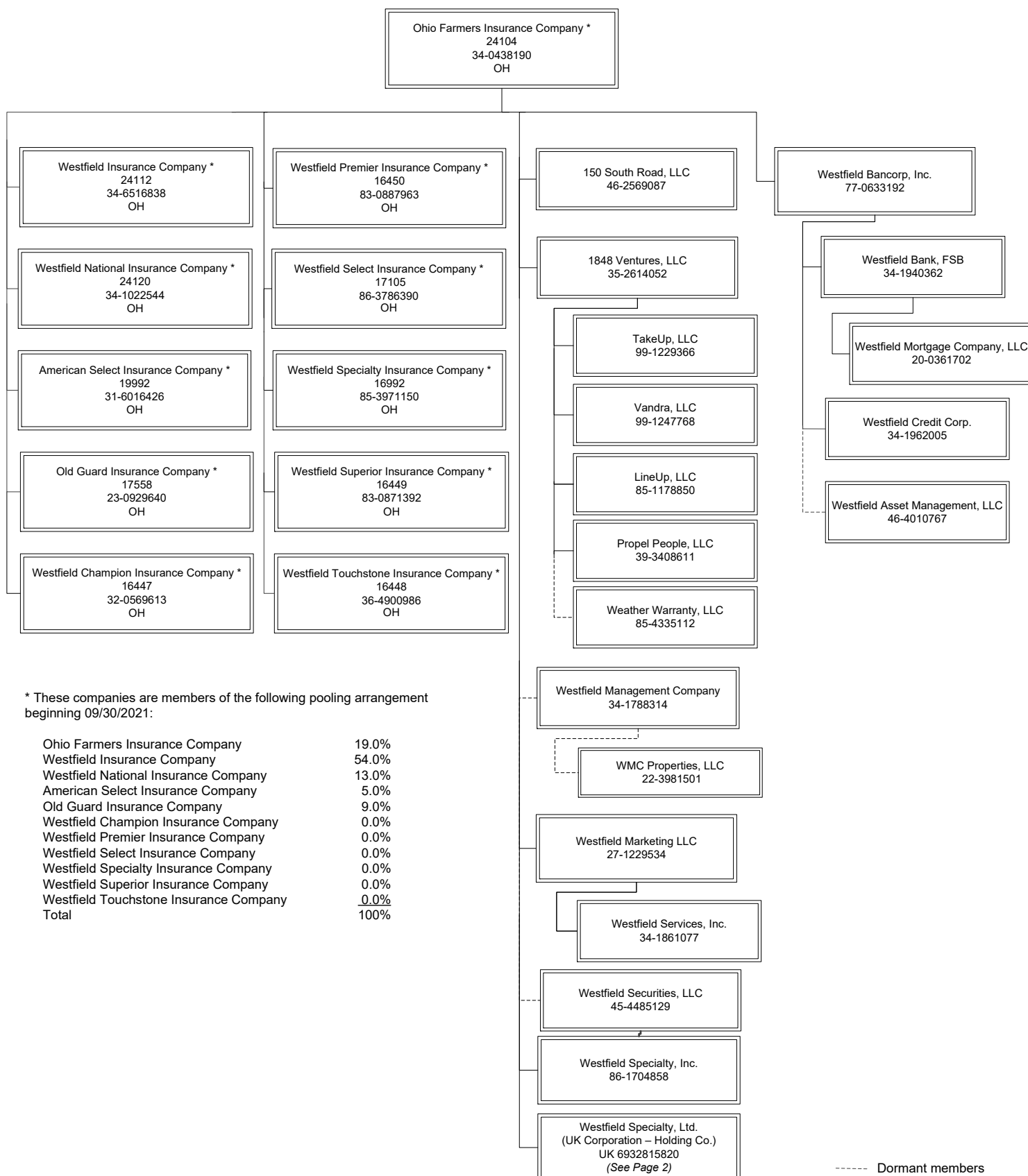

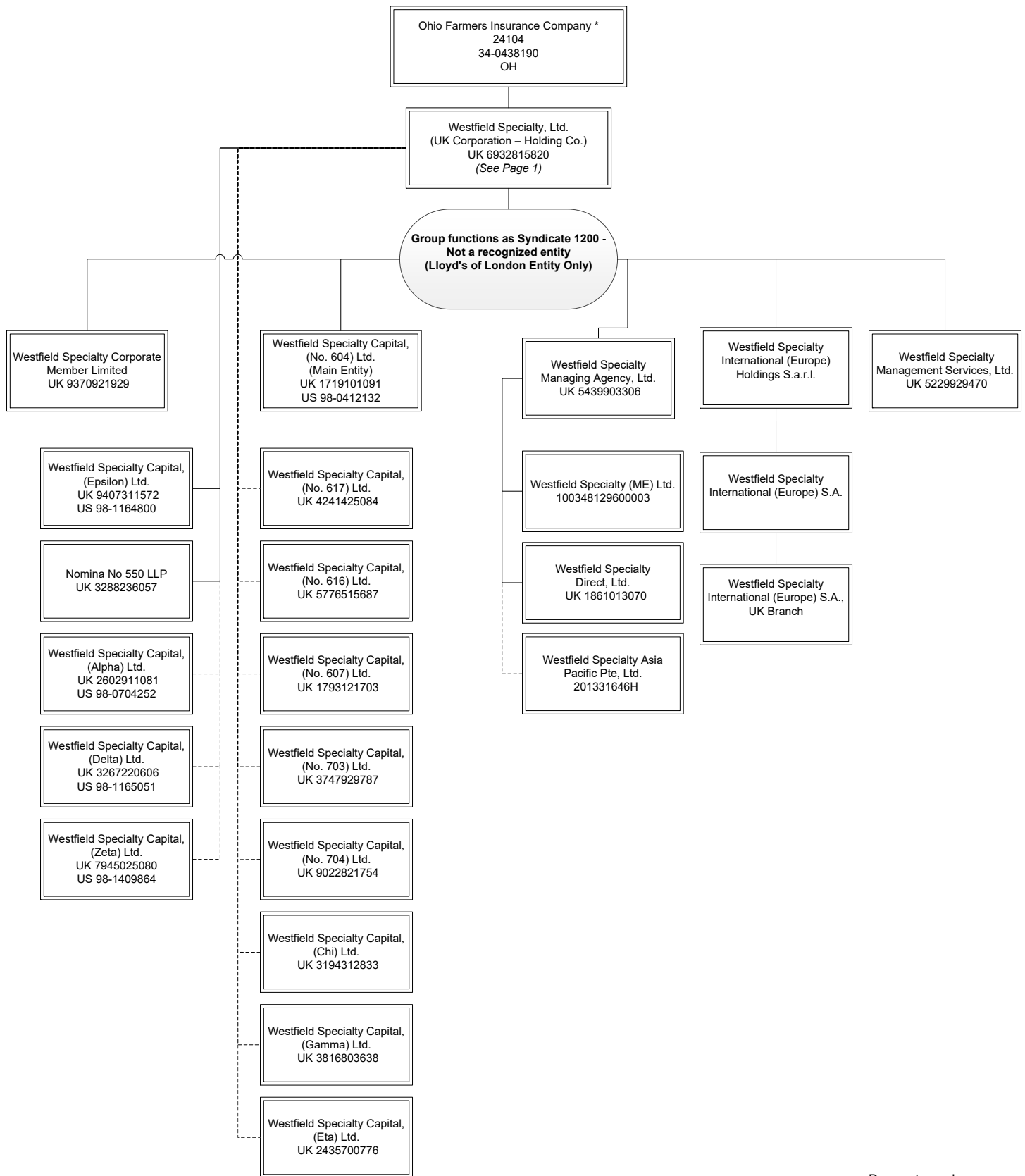
### PART 1 – ORGANIZATIONAL CHART
