ORDER

1. Premier Health Insuring Corporation (NAIC No. 15530) (the “Company”) was an Ohio-domiciled health insuring corporation. On or about April 22, 2014, the Company obtained a Certificate of Authority to transact the business of insurance in Ohio pursuant to Chapter 1751 of the Ohio Revised Code (R.C.).
2. Pursuant to R.C. Section 1751.27, the Company maintained a statutory security deposit with the Ohio Department of Insurance (the “Department”) in the amount of Four Hundred Thousand Dollars (\$400,000) (Exhibit A) (the “Security Deposit”).
3. On or about December 4, 2019, the Department entered an Order approving the voluntary surrender of the Company’s Certificate of Authority, effective December 31, 2019 (Exhibit B).
4. The Company, through its CFO, Timothy E. Henry, has requested release of the Security Deposit.

NOW THEREFORE IT IS ORDERED THAT:

The Interim Director hereby releases control of the Ohio statutory security deposit set out in Exhibit A to Premier Health Insuring Corporation.
