**NOTICE OF OPPORTUNITY FOR HEARING**

The Ohio Department of Insurance ("Department"), by and through the Superintendent, is charged with the responsibility of administering and enforcing Title 39 of the Ohio Revised Code ("R.C.") and the associated rules and regulations.

John Shedenhelm ("Shedenhelm") is currently licensed as a resident insurance agent in the State of Ohio. The Department, on behalf of the Superintendent, conducted an investigation of the activities of Shedenhelm. As a result of that investigation, the Department alleges that Shedenhelm committed violations of the laws and regulations of this State and that he is not suitable to be licensed as an insurance agent in the State of Ohio.

In accordance with R.C. Chapter 119 and Title 39, Shedenhelm is notified that the Superintendent intends to revoke his license as an insurance agent in the State of Ohio and/or impose any other sanction authorized by R.C. 3905.14(D) and (F), including civil penalties and/or administrative costs. The grounds for such action are alleged below.

**COUNT ONE**

On or about September 23, 2021, Shedenhelm was the subject of a Consent Agreement/Cease and Desist Order issued by the Ohio Department of Commerce, Division of Securities for selling unregistered securities without obtaining a securities salesperson license.

R.C. 3905.14(B)(18) provides that the Superintendent may suspend, revoke, or refuse to issue a license of an agent for having been subject to a cease and desist order or permanent injunction related to mishandling of funds or breach of fiduciary responsibilities or for unlicensed or unregistered activity.

Shedenhelm is hereby notified that he may request a hearing pursuant to R.C. Chapter 119. The Department must receive any request for a hearing within 30 days of the mailing of this Notice. The request must be in writing and directed to:

At the hearing, Shedenhelm may appear in person, by his attorney, or by such other representative as is permitted to practice before the agency, or he may present his position, arguments or contentions in writing and, at the hearing, Shedenhelm may present evidence and examine witnesses appearing for and against him.

If no hearing is requested, the matter will proceed to the Superintendent for decision where she may impose any sanction allowed by law.
